The City of Madison is proposing to reconstruct a portion of Hillcrest Drive and Hillcrest Circle in 2016. Enclosed with this letter is a fact sheet with some details on the proposed project, which includes a map of the proposed project limits. ## **Project Details – Proposed Work**

**Sanitary Sewer:** Replace the existing sewer main between Owen Dr. & Westmorland Blvd. with 8" PVC pipe (existing 6" clay main installed in 1940), and replace laterals to the property line (*laterals are assessable*). Line the existing main serving Hillcrest Cir. The remaining properties are served off of mains in backyards, and no work is proposed on those mains.

**Water Main:** Replace the existing water main within the project limits with 8" ductile iron pipe (existing 6" cast iron main was installed in 1939-40) and reconnect services to the new main.

**Storm Sewer:** There is not any existing storm sewer within the project limits. New storm sewer will be installed and connected to the storm sewer system at Midvale Blvd. New storm sewer inlets will be installed throughout the project, especially near intersections.

Street Lights: There are no proposed changes to the street lights.

**Street:** Replace all of the pavement and gravel base; install new curb and gutter, and replace driveway aprons to match into the new curb (*, curb, 4 ft. of the pavement and driveway aprons are assessable*). Existing sidewalk will be replaced as needed to repair damaged sections and as needed for sewer lateral replacement. The proposed street width is 24 ft. from face of curb to face of curb, which will allow for travel in both directions and parking on one side of the street. To preserve some large oak trees, the street will be narrowed to 21 ft. and have parking removed near the westerly intersection of Hillcrest Dr. & Circle and through 4325 Hillcrest Dr. The alignment of Hillcrest Dr. east of Owen Dr. will include some new bends in order to avoid existing trees and to provide some mild traffic calming. Disturbed areas will be restored with topsoil and grass seed, which will be watered as needed by the contractor for the first 10 days.

**Trees:** Efforts will be made to save as many of the existing trees as possible; however, there are several planned tree removals with this project. A list of locations of removals is on the reverse of this sheet. During construction, if any other trees must be removed, the adjacent properties will be notified prior to removal. Trees within the project limits that are to remain will be pruned by City Forestry prior to the start of construction, and some trees may require early season pruning. After the project, the site will be reviewed to replace removed trees and for possible new plantings.

# **Construction Schedule & Impacts**

Tentative Construction Schedule: Mid April until mid August

This proposed project is scheduled to be advertised for bids on January 22, 2015.

**Traffic Impacts:** Hillcrest Dr. and Hillcrest Circle will be closed to thru traffic within the project limits. Local access will be provided, but driveways may not be accessible at times when work is being performed in front of the driveway and while new concrete is curing. Driveway closures may last up to 20 days. No parking is allowed within the construction zone during working hours (7AM to 7PM), so when your driveway is not accessible, you will need to park on adjacent streets. Access will be maintained through the intersections with cross streets.

**Water Shut-offs:** An average of two water shut-offs are expected for each property within the project limits. A minimum of 48 hours of notice will be provided prior to the shut-offs. Each shut-off may last up to 8 hours, but typically lasts about 4 hours.

At the start of construction, the existing main will remain in service until the new main is installed and connected to; emergency shut-offs may occur if the old, brittle main is damaged during construction.

**Rock Trenching:** Soil borings were done on Hillcrest, and bedrock was found just a few feet below the surface. Specialized equipment will need to be used on this project to the excavate trenches through the rock for utility installation.

**Refuse Collection:** It will be the contractor's responsibility to allow for refuse collection during construction. Please mark your address on your cart to make sure it is returned if moved. Also, City Streets will collect in the construction area first thing in the morning, so please have your carts out before 7AM.

**Landscaping:** Any existing landscaping near or within the right-of-way will likely be removed during construction. If you wish to save any of that landscaping, it should be removed prior to the start of work. Contact the project engineer with questions regarding the limits of the work.
