

**ARTICLES OF INCORPORATION  
OF  
Mosaic Ridge HOMEOWNERS' ASSOCIATION, INC.**

Mosaic Ridge Homeowners' Association, Inc., a nonstock, nonprofit corporation organized under Chapter 181 of the Wisconsin Statutes, hereby adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation is: Mosaic Ridge Homeowners' Association, Inc. ("Association").

**ARTICLE II  
PERIOD OF EXISTENCE**

The period of existence of the Association is perpetual.

**ARTICLE III  
PURPOSE**

The Association is organized to serve as an association of residential homeowners for the Mosaic Ridge Subdivision, located in the City of Madison, Dane County, Wisconsin, (the "Subdivision") and to exercise the powers, carry out the responsibilities, and otherwise engage in any lawful activity authorized and permitted by Wis. Stats. § 181.

**ARTICLE IV  
MEMBERS**

The Association shall have members. Membership provisions (including the designation of classes, if any, and the method of acceptance of members of each such class) shall be set forth in the Bylaws of the Association (the "Bylaws"). The respective voting rights of the members of the Association shall be as set forth in the Bylaws.
