PURSUANT TO SECTION 38 OF THE MADISON GENERAL ORDINANCES AND
 CHAPTER 125 OF THE WISCONSIN STATE STATUTES.

Premise: approximately 1,800 square feet. No bar. Beer stored in cooler. Wine stored in cooler and in displays in front of coolers. Beer and wine sold at counter. Outdoor café.

Common Council granted March 29, 2005, with the following conditions:

- 1) No sale of liquor other than wine (voluntary condition).
- 2) No sale of single cans or single bottles of beer or fermented malt beverages.
- 3) No sale of fortified wines.
- 4) Display of beer and wine will be limited to four doors of current cooler.
- 5) No consumption of alcohol at sidewalk cafe after 9:00 p.m.

Common Council approved a premise change 3/29/2011.
