### Why I want to serve:

I love my home. I grew up in Madison, and even when I was gone (for school or family reasons), I felt its pull on me. I returned, because this is where I want to raise my daughter. I am an enrolled member of the Ho-Chunk Nation, and one thing that is important to our culture is working together as a community. It is from that perspective that I see public service. I've gotten so much from this city, I feel a responsibility to give back.

I've had opportunities to give back to at various levels, by helping empower other Native Americans to make their voices heard on election day, by encouraging youth to continue their educations by preparing for college, as well as encouraging various units of government to work with their tribal neighbors. Because my professional opportunities kept me traveling the state quite a bit, it was hard for me to get involved at a more local level. Now that I am consistently "at home," I've been looking at opportunities to serve my Madison community.

My previous work with state, local, and federal governments has prepared me for the different kinds of relationships each level of government has with the others, as well as with the communities they serve.

We are lucky to live in Madison, with a great standard of living, safe neighborhoods, thriving art scene, and access to natural resources. It would be my great honor to represent the 11th District and help make it even better for all of us.

#### Goals in Office:

Transparency and Engagement: The 11st District has a great deal of very engaged constituents. I want to remain open, and provide good channels of communication between me and the residents of District 11. I would engage in person, both at doors or neighborhood forums or meetings, as well as online, with social media and email.

Lessening Racial Disparities: The experience that I have had as a resident of Madison is not a universal one.
