NOW COMES the City of Madison by Kristen Roman, Lieutenant of the Madison Police Department, and alleges as follows, that:

- The Complainant, Lieutenant Kristen Roman, is an adult resident of the City of Madison, with a business address of 211 S Carroll St., Madison, Wisconsin, and at all times material to this action, she was and is a member of the City of Madison Police Department, in her official capacity.
- 2. The respondent herein, University Sports Inc, Ion Okonek, agent, is the alcohol beverage licensee doing business as Johnny O's Restaurant and Bar, 620 University Ave, Madison, Wisconsin, according to documents filed with the City Clerk of the City of Madison.
- 3. The Common Council of the City of Madison granted a renewal of respondent's Class B Combination Alcohol Beverage License for the period July 1, 2008

through June 30, 2009. At all times alleged in this complaint, respondent was the holder of a Class B Combination Alcohol Beverage License issued by the City of Madison.

- 4. Respondent has filed a renewal application for his Class B Combination Alcohol Beverage License for the period July 1, 2009 through June 30, 2010.
- 5, In August 2008 an Alcohol License Emergency Response Team ("ALERT") meeting was held with Jon Okonek, ("Okonek") to discuss alleged violations of Chapter 38, the City's liquor code, of the Madison General Ordinances ("MGO") and to explore possible solutions to these problems in order to avoid further and repeated disciplinary actions
- On November 19, 2008 Madison Police Department's Central Community Policing Team held a special training session for all employees of Johnny O's, including Okonek, in attempt to educate Okonek and his employees in order to facilitate compliance with Chapter 38, MGO
- 7. On information and belief, the licensee, under the City of Madison Class B Combination Alcohol Beverage License for the retail sale of alcohol beverages at the premises known as Johnny O's, 620 University Ave, Madison, Wisconsin, has, since the above meetings, continued to violate various provisions of Chapter 38, MGO, as set forth in Madison Police Department officers' reports, to wit:

VIOLATIONS OF CHAPTER 38 OF THE MADISON GENERAL ORDINANCES WITHIN THE MEANING OF SEC. 38.10(1)(a)1 MADISON GENERAL ORDINANCES

8. On May 8, 2008, at approximately 11:43 p.m., Madison Police Officers Kraig Knutson and Jason Johnson reported that five underage patrons were allowed into Johnny O's in violation of Sec. 38.04(2)(b) [Unlawfully Permit Underage Person On

Licensed Premise] Officer Knutson first contacted Anna Myaskovsky, D/O/B She had been drinking alcohol on the rooftop deck when contacted. She admitted showing a fake North Carolina driver's license to door employees to gain entry into Johnny O's. Officer Knutson confiscated this driver's license and issued Myaskovsky a citation for Underage Person Enters Licensed Premise Next, Officer Knutson contacted Elizabeth Miracle, D/O/B who admitted to showing a fake New Jersey identification card to door employees to gain entry into Johnny O's. Officer Knutson confiscated this identification card and issued Miracle a citation for Underage Person Enters Licensed Premise. Officer Knutson then contacted Rebecca Miller, D/O/B Miller admitted to showing a fake South Carolina driver's license, which she purchased of the Internet, to the door employees to gain entry into Johnny O's The lamination on this ID was in poor condition and stated it was not a DL but was for identification purposes only. Officer Knutson confiscated this identification card and issued Miller a citation for Underage Person Enters Licensed Premise. Officer Johnson contacted Jenna Westrick, D/O/B on the rooftop deck. Westrick provided Officer Johnson an Indiana ID that appeared to be fake Officer Johnson confiscated this identification and issued Westrick a citation for Underage Person Enters Licensed Premise Officer Johnson then contacted Karli Levin, D/O/B who provided Officer Johnson a Michigan ID that appeared to be fake. Officer Johnson confiscated this identification and issued Levin a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-123598.

9. On May 24, 2008, at approximately 1:39 a.m., Madison Police Officers Jason Johnson and Kraig Knutson reported that two underage patrons were allowed into

Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. Officer Knutson contacted Ashley Maltz, D/O/B who was in possession of beer when contacted. She admitted that she was allowed into Johnny O's without producing identification because friends of hers knew an employee. Maltz was issued a citation for Underage Person Enters Licensed Premise. Officer Johnson contacted Lindsay McGuire, D/O/B McGuire admitted to showing a New York driver's license that was not hers to the door employees to gain entry into Johnny O's. The license she used had a birth date of presenting McGuire as being five years older than she actually was. Officer Johnson confiscated the driver's license and issued McGuire a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-139624.

On May 31, 2008, at approximately 1:00 a.m., Madison Police Officers Carrie Hemming and Kraig Knutson report that three underage patrons were allowed into Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. Officer Hemming contacted Britta Rowan, D/O/B and Noah Welhouse, D/O/B inside Johnny Os'. Both individuals indicated they were under the age of twenty-one and both were issued citations for Underage Person Enters Licensed Premise. Officer Knutson contacted Callie Supple, D/O/B Supple admitted to showing another person's Illinois driver's license to door employees to gain entry into Johnny O's. The driver's license she used had a birth year of 1983, making her 24 years of age. Officer Knutson indicated that Supple did not look 24 years of age, nor did she look like the photograph or match the physical description provided on the license. Officer Knutson confiscated the driver's license and issued Supple a

citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-146715.

- Kraig Knutson and Carrie Hemming contacted two underage patrons who were allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise] Officer Knutson contacted Erin Seider, D/O/B on the rooftop deck. She admitted to entering Johnny O's without producing any identification because the people she was with knew an employee who worked here. Seider was issued a citation for Underage Person Enters Licensed Premise. Officer Hemming contacted Nicholas Balge, D/O/B on, who was also on the rooftop deck, Balge indicated he had consumed alcohol at Johnny O's. He admitted to showing his real driver's license showing him to be only 20 years old to the door employee to gain entry into Johnny O's. Balge was issued a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-147821.
- Jason Johnson, Tim Radke and Kraig Knutson reported that three underage patrons were allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. Officer Johnson contacted Andrea Christensen, D/O/B , inside Johnny O's Christensen stated she had shown a driver's license that is not hers to the door employees to gain entry into Johnny O's Officer Johnson confiscated the driver's license that showed a birth year in 1982, making Christensen 25 years old and issued Christensen a citation for Underage Person Enters Licensed Premise. Officer Radke contacted Leora Grushka, D/O/B

admitted to showing a fake Minnesota driver's license to the door employees to gain entry. Officer Radke confiscated the driver's license and issued Grushka a citation for Underage Person Enters Licensed Premise. Officer Knutson contacted Corey Dick, D/O/B, on the rooftop deck. Dick admitted to consuming alcohol at Johnny O's. He also admitted to showing a Wisconsin driver's license that was not his to the door employee to gain entry into Johnny O's. Officer Knutson noted that the driver's license he used showed a height of 5'9", while Dick is actually 6'1". Officer Knutson also indicated that the physical descriptions, as well as the photograph on this license did not resemble Dick. Officer Knutson confiscated the driver's license and issued Dick a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-153209.

- Jason Johnson reports that one underage patron was allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. Officer Johnson contacted Emily Crawford, D/O/B who admitted to showing a fake California driver's license with her correct name and birthday, but incorrect birth year, to the door employees to gain entry into Johnny O's. Officer Johnson confiscated the fake driver's license and issued Crawford a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-154545.
- 14. On July 26, 2008, at approximately 12:30 a m., Madison Police Officers Angie Dyhr and Javier Loredo report that two underage patrons were allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person

On Licensed Premise]. Officer Loredo contacted Deanna Harris, D/O/B and and Leah Zaharoff, D/O/B who indicated that they had climbed over a fence to gain entry into the front outdoor beer garden area. However, they both also had fake Massachusetts's driver's licenses on their persons, which they turned over to Officer Loredo. Harris and Zaharoff were each issued citations for Underage Person Intentionally Carries Identification to Convey False Information. This incident can be found under Madison Police Case #08-211854.

- On August 3, 2008, at approximately 12:24 a.m., Madison Police Officer Grant Humerickhouse reports that one underage patron was allowed inside Johnny O's in violation of Sec. 38 04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. While conducting a bar check inside Johnny O's, Officer Humerickhouse contacted Charise Mancheski, D/O/B Mancheski was observed holding a mixed drink of alcohol. Mancheski surrendered a driver's license that was not hers to Officer Humerickhouse. That driver's license showed a birth year of 1981. Mancheski was issued a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-221015
- On August 23, 2008, at approximately 1:11 a m., Madison Police Officers Grant Humerickhouse, Jason Johnson, and Carrie Hemming report that four underage patrons were allowed inside Johnny O's in violation of Sec. 38 04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. Officer Humerickhouse contacted Lauren Piscione, D/O/B after watching her exit Johnny O's. Piscione smelled strongly of intoxicants and admitted to showing her altered New York driver's license to the Johnny O employees to gain entry. Officer Humerickhouse confiscated this

driver's license and issued Piscione a citation for Underage Person Not To Possess/Consume Alcohol off Licensed Premise Officer Johnson contacted David Gilberg, D/O/B , who had exited Johnny O's. Gilberg admitted to showing a driver's license that was not his to Johnny O's employees to gain entry. Officer Johnson confiscated that driver's license and issued Gilberg a citation for Underage Person Enters Licensed Premise. Officer Johnson then contacted Emily Bader, D/O/B after watching Bader enter Johnny O's without providing identification to any door employee. Bader had a beer in her hand and was drinking the beer, when contacted by Officer Johnson inside Johnny O's. She also was in possession of a fake New York driver's license, which Officer Johnson confiscated. Bader was issued citations for Underage Person Not To Possess/Consume Alcohol Off Licensed Premise and Underage Person Enters Licensed Premise. Officer Hemming contacted Lauren Cayne, D/O/B the rooftop deck at Johnny O's. Cayne originally said she was let into Johnny O's without having to produce identification because she knew an employee. Once she was told that Johnny O's uses video surveillance at the entrance, Cayne admitted to showing a New York driver's license that is not hers to door employees to gain entry. She said she passed this driver's license off to a friend who was over twenty-one when she got in. Cayne was issued a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-243538 and 08-243569.

On October 11, 2008, at approximately 12:27 a.m., Madison Police Officer Jason Johnson reports that one underage patron was allowed inside Johnny O's in violation of Sec. 38 04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise] Officer Johnson contacted Lauren Klein, D/O/B , inside Johnny O's

Klein had in her possession a fake Colorado driver's license with her correct name and birthday, but incorrect birth year. Officer Johnson confiscated the fake driver's license and issued Klein a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #08-299303.

- Grant Humerickhouse reports that two underage patrons were allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. Officer Humerickhouse contacted Danielle Coren, D/O/B and Kelly Klein, D/O/B inside Johnny O's. Officer Humerickhouse had recognized Coren from past police contacts as being under twenty-one years of age. Coren surrendered a fake New York driver's license to Officer Humerickhouse and was issued a citation for Underage Person Enters Licensed Premise Officer Humerickhouse then contacted Klein, who originally indicated she was over 21 years of age. Klein eventually produced her New York driver's license, which had been altered to change her date of birth from Officer Humerickhouse confiscated this license and issued Klein a citation for an Underage Person Enters Licensed Premise This incident can be found under Madison Police Case #08-312875.
- Officers Grant Humerickhouse and Jason Johnson report that eight underage patrons were allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. Officer Humerickhouse contacted Eric Goldstein, D/O/B Goldstein produced a fake New Jersey driver's license to Officer Humerickhouse insisting it was real Officer Humerickhouse knew that this

identification was fake because the hologram images were inconsistent with images on a real New Jersey driver's license. Goldstein was issued citations for Underage Person Intentionally Carrying ID Not Theirs, Underage Person Not To Possess/Consume Alcohol On Licensed Premise, Underage Person Enters Licensed Premise and Obstructing a Peace Officer Officer Humerickhouse then contacted Bari Pelton, D/O/B inside Johnny O's. Pelton produced a New York driver's license that had been altered. This driver's license showed a picture of someone other than Pelton and it was obvious that the date of birth had been altered. Pelton was issued a citation for Underage Officer Humerickhouse then contacted Jessica Person Enters Licensed Premise Rauchman, D/O/B (assert), after seeing her engaged in aggressive behavior towards another patron. Once outside, Officer Humerickhouse noted Rauchman had been drinking. Rauchman stated that she walked into Johnny O's without having to produce identification because she told the door employees that she was just going inside to find her roommate. Rauchman was issued a citation for Underage Person Enters Licensed Premise. Officer Johnson contacted Corey Hein, D/O/B and Alexander Valley, D/O/B who were inside Johnny O's ordering a pitcher of beer. Both Hein and Valley had fake identification on them, which they turned over to Officer Johnson. Hein and Valley were issued citations for Underage Person Enters a Licensed Premise. Officer Johnson then saw Emily Bader, D/O/B past police contacts, was under twenty-one years of age. Bader admitted she walked into Johnny O's without having to produce identification to the door employees. Bader was issued a citation for Underage Person Enters Licensed Premise. Officer Johnson then contacted Taylor Mahan-Rudolph, D/O/B , inside Johnny O's. She produced a fake Texas driver's license that Officer Johnson confiscated. Mahan-Rudolph was issued a citation for Underage Person Enters Licensed Premise. Officer Johnson then contacted Gabrielle Wolin, D/O/B inside Johnny O's holding a bottle of beer. Wolin originally produced a New York driver's license that was obviously not her in the photograph Wolin than admitted it was her sister driver's license and that she was under twenty-one years of age. Officer Johnson confiscated the driver's license and issued Wolin a citation for Underage Person Enters Licensed Premise. Officer Humerickhouse reported that as he and Officer Johnson entered Johnny O's on several occasions, other patrons who were never contacted by police left the establishment en mass, even though it was not time for Johnny O's to close. This incident can be found under Madison Police Case #09-21493.

Sergeant Tony Fiore and Officers Jason Johnson and Grant Humerickhouse report that four underage patrons were allowed inside Johnny O's in violation of Sec 38.04(2)(b), MGO [Unlawfully Permit Underage Person On License Premise] Officer Johnson contacted Alexander Pruzinsky, D/O/B and Jacob Dejno, D/O/B inside Johnny O's as they were drinking beer. Denjo readily admitted that he was underage and had showed a friend's license to door employees to gain entry to Johnny O's. Denjo was issued a citation for Underage Person Not To Possess/Consume Alcohol Off Licensed Premise. Johnson then contacted Pruzinsky who indicated that his identification was at the bar, he then attempted to flee from Officer Johnson. Pruzinsky was caught and surrendered a fake Virginia driver's license with correct name and birthday on it, but with an incorrect birth year. Pruzinsky was issued citations for Obstructing a Peace Officer,

Underage Person Not To Possess/Consume Alcohol On Licensed Premise, Underage Person Enters Licensed Premise and Underage Person Intentionally Carrying ID Not Theirs. Sergeant Fiore contacted Ian Ragonese-Barnes, D/O/B (1997), inside Johnny O's. Ragonese-Barnes had been with Denjo and Pruzinsky and had been observed by Officer Johnson drinking beer. Ragonese-Barnes indicated that his identification was at the bar, he then attempted to flee from officers. He was caught by Sergeant Fiore and admitted to walking into Johnny O's without having to produce any identification to the door employees. Ragonese-Barnes was issued citations for Underage Person Enters Licensed Premise and Obstructing a Peace Officer. Officer Humerickhouse contacted Khylie Urban, D/O/B (1997), inside Johnny O's Urban produced a fake driver's licensed to Officer Humerickhouse and was issued a citation for Underage Person Enters Licensed Premise. This incident can be found under Madison Police Case #09-22652.

On January 30, 2009, at approximately 12:50 a m, Madison Police Sergeant Tony Fiore, and Officers Grant Humerickhouse and Jason Johnson report that fourteen underage patrons were allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. As Sergeant Fiore approached Johnny O's he observed approximately forty people pushing and shoving trying to get to the front door, there was no organized line and the individuals standing in front of the group were extremely tightly packed in. At the door Sergeant Fiore observed a bouncer standing with his arm braced across the threshold of the door, preventing anybody from entering Johnny O's. Inside Johnny O's, Sergeant Fiore contacted Jessica Ward, D/O/B and Lauren Edelman, D/O/B Ward produced a fake Texas driver's license that had her correct name and birth date on it, but

her incorrect birth year. Edelman produced a fake New York driver's license with her correct name and birth date but incorrect birth year. Both fake drivers' license were confiscated and both individuals were written a citation for Underage Person Enters Licensed Premise. Sergeant Fiore then contacted Gabriel Katz, D/OB/ originally produced a fake Texas driver's license but later admitted he was underage producing his real New York driver's license. The fake driver's license was confiscated and Katz was issued a citation for Underage Person Enters Licensed Premise. Next Sergeant Fiore contacted Matthew Siegel, D/O/B , who stated that he showed his real New York driver's license that showed his birth date to be in making him eighteen years old, to door employees in order to gain entry into Johnny O's Siegel stated to Sergeant Fiore "They don't even care. You just hand it to 'em and they hand it back to you and let you in,", speaking about the door employees and the fact that he was under the age of twenty-one. Siegel was issued a citation for Underage Person Enters Licensed Premise. Next Sergeant Fiore contacted Ariel Rischall, D/OB (Mark), who stated he did not have any form of identification that was not him He said he did not have to produce any identification to the door employees in order to gain entry into Johnny O's. Rischall was issued a citation for Underage Person Enters Licensed Premise. Officer Johnson contacted Arielle Garti, D/O/B (Sarah Osman, D/O/B) and Marc Sideroff, D/O/B , inside Johnny O's Garti and Osman both admitted to not having to produce any identification to the door employees to gain entry. Sideroff first lied that he was twenty-one but later admitted that he did not have any identification on him and that he was nineteen years of age Garti, Osman and Sideroff were issued citations for Underage Person Not To Possess/Consume Alcohol On Licensed Premise.

Officer Johnson then contacted Jessica Rauchman, D/O/B (inside Johnny O's. Officer Johnson recognized Rauchman from prior police contact. Rauchman asked Officer Johnson to "give her a break". Rauchman was issued a citation for Underage Person Enters Licensed Premise Officer Humerickhouse contacted Marc Ehernman, inside Johnny O's. Ehernman was consuming intoxicants at the bar. When asked, Ehernman surrendered his fake identification. Ehernman was issued a citation for Underage Person Enters Licensed Premise. Next Officer Humerickhouse contacted Jonathan Rosenbaum, D/O/B inside Johnny O's. Rosenbaum appeared to have been drinking alcohol and surrendered his fake identification. Rosenbaum was issued a citation for Underage Person Enters Licensed Premise. Next Officer Humerickhouse contacted Elissa Alster, D/O/B (inside Johnny O's. Alster appeared to have been drinking alcohol. She surrendered her fake New York driver's license when asked. Alster was issued a citation for Underage Person Enters Officer Humerickhouse next contacted Michaela Jones, D/O/B Licensed Premise. , inside Johnny O's. Jones appeared to have been consuming alcohol. When asked, Jones surrendered her fake Massachusetts's driver's license. Jones was issued a citation for Underage Person Enters Licensed Premise. Next Officer Humerickhouse contacted Cody Milch, D/O/B inside Johnny O's. Milch appeared to have been drinking alcohol and surrendered his fake New York's driver's license. Milch was issued a citation for Underage Person Enters Licensed Premise During the time that officers were inside Johnny O's, Sergeant Fiore observed numerous patrons leave Johnny O's even though it was well before the bar's closing time. Sergeant Fiore believed that if more officers had been available to assist, even more underage patrons would have been found Officers watched as patrons tried to scurry away from them, but they could only detain so many people at a time. This incident can be found under Madison Police Case #09-28242.

On February 6, 2009, at approximately 1:17 a.m., Madison Police 22. Sergeant Tony Fiore and Officers Grant Humerickhouse, Javier Loredo, Jason Johnson and Carrie Hemming report that eight underage patrons were allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. As Sergeant Fiore was entering Johnny O's, he saw Evan Shusterhuff, D/O/B attempting to exit in a hurry. Sergeant Fiore observed a strong odor of intoxicants coming from Shusterhuff and that his speech was slurred. initially stated that he did not have any identification on him but then eventually surrended his fake identification Shusterhuff admitted to consuming a few alcohol beverages inside Johnny O's. Shusterhuff was issued a citation for Underage Person Sergeant Fiore, then observed Chloe Sepelmaier, D/O/B Enters Licensed Premise who appeared to avoid eye contact with Sergeant Fiore. Sepelmaier stated that she did not have any identification on her and that she had snuck past security at the front door without providing any identification. Sepelmaier was issued a citation for Underage Person Enters Licensed Premise Sergeant Fiore then contacted Joanne Nathan, D/O/B , who attempted to avoid contact with Sergeant Fiore by attempting to walk away. Sergeant Fiore was able to make contact with Nathan and Lisa Chiswick, D/O/B both indicated that they did not have identification on them. They stated that they were able to get into Johnny O's by "wedging in", which they described as several persons would attempt to enter Johnny O's at the same time and they would just move through as well. Nathan and Chiswick were issued citations for Underage Person Enters Licensed Premise Officer Humerickhouse contacted Jade Port, D/O/B and Samantha Glass, D/O/B inside Johnny O's. - Sergeant Tony Fiore and Officers Carrie Hemming and Pedro Ortega-Mendoza report that three underage patrons were allowed inside Johnny O's in violation of Sec. 38.04(2)(b), MGO [Unlawfully Permit Underage Person On Licensed Premise]. Sergeant Fiore contacted Preston Paulson, D/O/B inside Johnny O's. Paulson insisted that he used his own identification that showed he was eighteen years of age to gain entry into Johnny O's. Sergeant Fiore contacted the bouncer at the door and showed him Paulson's identification and informed him of Paulson's statements that he had used this

identification to enter Johnny O's, the bouncer did not dispute or attempt to repudiate this fact. Paulson was issued a citation for Underage Person Enters Licensed Premise. Officer Hemming contacted Emily O'Donnell, D/O/B (inside Johnny O's. Demetrius-Lalas provided an Illinois driver's license that contained her personal information and that she was nineteen years of age. McCormick was issued citations for Underage Person Enters Licensed Premise, Underage Person Not To Possess/Consume Alcohol on Licensed Premise, Underage Person Carries Identification Knowing the Information Contained Therein is False and Obstructing a Peace Officer This incident can be found under Madison Police Case #09-108390.

29,. On April 18, 2009, at approximately 1:46 a.m., Madison Police Officers Carrie Hemming and Linda Tervarthen were standing in the 600 block of University Avenue, outside Johnny O's. A Johnny O's bouncer contacted the officers and stated that there was a female in the bathroom passed out. (A violation of Sec. 38.04(1)(a)3 [Permit Intoxicated Person On Licensed Premise]. When Officer Hemming entered the bathroom she observed Juewei Cheng, D/O/B , beginning to stand up with the assistance

of a Johnny O's employee. This employee stated that when she entered the bathroom she saw Cheng beneath the stalls and appeared to be passed out. Cheng's underwear was around her ankles and the employee helped to dress her. The employee said that prior to police arrival Cheng was completely unresponsive. Officer Knutson contacted Josh Gooley, D/O/B , who admitted to urinating on the rooftop. Gooley was issued a citation for Depositing Human Waste. This incident can be found under Madison Police Case #08-124797.
- 2. On May 17, 2008, at approximately 12:04 a.m., Madison Police Officers Kraig Knutson, Carrie Hemming and Tim Radke observed three different incidents occurring on the rooftop beer garden area at Johnny O's. Werner then tried to interfere by telling Pressley not to take Frey away that Werner "would handle him". Pressley ended up shoving Werner away with an open palm to his chest causing Werner to fall. Werner claims this fall caused a minor injury to his eye and elbow. Employees, then escorted outside both Frey and Werner. Werner and Fry were intoxicated and were issued citations

Weber was arrested for Disorderly Conduct and taken to the Dane County Jail. Degnan was arrested for Disorderly Conduct, Possession of Drug Paraphernalia and Casual Possession of Marijuana in a Public Place and taken to the Dane County Jail. - On August 17, 2008, at approximately 12:40 a.m., Madison Police Officer Carrie Hemming was on routine foot patrol when she contacted Steven Conner, D/O/B outside of Johnny O's. Conner was holding an opaque plastic cup with a yellow orange liquid inside. Conner indicated that the substance was orange juice and vodka and that he had just left Johnny O's with the drink. Conner was issued a citation for Open Intoxicants on a Public Street or Sidewalk. This incident can be found under Madison Police Case # 08-236582.
- Officer Carrie Hemming was on routine foot patrol outside of Johnny O's when she observed Gregory Edlin, D/O/B throw a lighted cigarette off the rooftop deck onto the crowd of people gathering in the ground level outdoor area. Edlin was issued a citation for Disorderly Conduct. This incident can be found under Madison Police Case # 08-275543.
- On October 11, 2008, at approximately 1:52 a.m., Madison Police Officer Carrie Hemming was on routine foot patrol outside of Johnny O's when she observed bouncer Matthew Muller trying to remove patron Matthew Vengal, D/O/B from the ground floor outdoor area via going over the metal railing. Officers assisted in removing and detaining Vengal. Muller said he began to remove Vengal because it appeared that he was about to become confrontational with another group of males. Vengal said that while it was true it he was upset, it was because the group of 6-8 unidentified males was calling him racially charged names. Vengal however, was unable

to point out exactly who called him the names. Officer Hemming had previously observed a group of male patrons before this disturbance who appeared very intoxicated and loud, and were chanting at many patrons of both Johnny O's, Madison Avenue and anyone else who happened to walk by Officers told the group of unidentified males to leave the Johnny O's because of their level of intoxication and their inability to make good choices. This incident can be found under Madison Police Case # 08- 299404.

- On October 26, 2008, at approximately 1:00 a.m., Madison Police Officer Carrie Hemming was on routine foot patrol in the 600 block of University Ave when she observed bouncer John O'Connell trying to intercede in a disturbance in the line of people waiting to get into Johnny O's. O'Connell pointed out Kristy Pociask, D/O/B and Jermal Chandler, D/O/B as being involved. O'Connell reported that an unidentified patron had stepped in front of Pociask in line. This led to a verbal shouting match between the two and then some pushing and shoving. Because of the dense crowd it was difficult for both O'Connell and Officers to see exactly what occurred in line because the crowd was a mass of people not one specific line waiting to get in By the time Officers waded into the crowd to detain Pociask and Chandler, the unidentified male patron who had cut in line had fled. Chandler however, was still yelling at O'Connell. Chandler admitted to pushing this individual and yelling and was issued a citation for Disorderly Conduct. This incident can be found under Madison Police Case # 08-315270
- 20. On October 26, 2008, at approximately 2:25 a.m., Madison Police Sergeant Dave McCaw was in the 600 block of University Ave monitoring the bar time crowd when he saw Ryan Shimko, D/O/B involved in a pushing match with

another unidentified person just outside the door of Johnny O's. When Sergeant McCaw went to intercede, Shimko continued the pushing and shouting, but this time with another unidentified party. Sergeant McCaw detained Shimko, who was very intoxicated. Shimko was issued a citation for Disorderly Conduct. This incident can be found under Madison Police Case # 08-315340.

- Jason Johnson and Grant Humerickhouse were dispatched to Johnny O's on the report that a bouncer had been punched and an individual was being detained. Upon arrival Officers saw that bouncers were detaining patron James Hausserman, D/O/B Employee Riley Schroeder stated that as he was asking patrons to leave at bar time, he accidentally bumped into Hausserman, who took offense to this and threw a beer at Schroeder. Schroeder and other employees then forcibly escorted Hausserman Hausserman struggled with employees who were trying to remove him and Hausserman punched Schroeder with a closed fist in the nose. Officer Humerickhouse observed Schroeder's nose was red and slightly swollen. Hausserman was very intoxicated and stated he did not remember the incident. Hausserman was cited for Battery and released. This incident can be found under Madison Police Case # 09-21570.
 - Sergeant Galen Wiering responded to Johnny O's for a disturbance. This was at the same time officers were investigating an unrelated event at neighboring Madison Avenue Dispatch advised that a disturbance had occurred inside Johnny O's. When Sergeant Wiering responded to Johnny O's, he observed Johnny O's employees Nicalus Tatro and Jacob Huck had escorted several patrons outside. Huck was not actually working that

night, he was there as a patron of Johnny O's and felt he needed to assist in the disturbance. One patron Brittany Fermann, D/O/B was complaining that Huck had elbowed her in the chest. Subsequent investigation showed this was probably not the case and that Fermann made have gotten pushed unintentionally during a disturbance. Huck was simply trying to keep uninvolved partied away from the disturbance that other bouncers were dealing with. This incident can be found under Madison Police Case # 09-44699.

- Sergeant Tony Fiore was conducting a tavern safety check at Johnny O's, when he observed two long wooden tables positioned in the back of the bar area, with six to eight people crowded around the tables. Sergeant Fiore observed numerous plastic cups on the tables and individuals standing around the tables holding pitchers of beer. As Sergeant Fiore observed this group, he discovered that several of the individuals were playing a commonly known drinking game known as "beer pong". Sergeant Fiore observed this activity for approximately three to four minutes and it appeared to be happening with the Johnny O's staff's knowledge. This incident can be found under Madison Police Case #09-57886
- On April 10, 2009, at approximately 12:42 a.m., Madison Police Officer Loredo was in the process of issuing a citation to an underage female who had illegally entered Johnny O's, when Justin Camacho, D/O/B process, approached and attempted to get the phone number for the underage female. Officer Loredo repeatedly requested that Camacho stop interrupting his investigation and back away from the scene. Camacho

refused to comply with Officer Loredo's request and was issued a citation for Obstructing a Peace Officer. This incident can be found under Madison Police Case #09-100056.

Brian Chaney was on a routine tavern check at Johnny O's. While standing on the sidewalk outside Johnny O's, Officer Chaney observed Andrew Cohen, D/O/B standing in line. Officer Chaney observed Cohen strike another male with a closed fist on his chest. There were approximately forty-five people in line waiting to get into Johnny O's. Cohen's action created a disturbance, Officer Chaney heard multiple people yelling and screaming and observed several people pushing others in line. Cohen was placed in handcuffs and searched. Officer Chaney found a fake Minnesota driver's license in Cohen's pocket. Cohen had a slight odor of intoxicants on his breath. Officer Chaney issued Cohen citations for Underage Person Carries Identification Not Theirs and Disorderly Conduct. This incident can be found under Madison Police Case #09-107038.

VIOLATED CAPACITY RESTRICTION IN VIOLATION OF MADISON GENERAL ORDINANCE SECTION 38.12(1)(a)

On May 17, 2008, at approximately 12:04 a m., Madison Police Officer Carrie Hemming entered Johnny O's to investigate an incident of items being thrown off the rooftop deck. Upon entering Johnny O's, Officer Hemming had to struggle to pass through the lower level due to the large number of patrons inside. Officer Hemming exited Johnny O's to complete her investigation and upon her return 5 minutes later it appeared as though the crowd had thinned out but was still over crowded. Officer Hemming counted 186 individuals on the rooftop deck and 223 individuals on the lower floor of Johnny O's. Officer Hemming reviewed the capacity information behind the bar,

which indicated the capacity was 386 Officer Hemming then again counted and counted 274 individuals on the first level and counted 160 individuals on the rooftop deck. Officer Hemming contacted manager, Marshall Childs, who indicated that he believed the upstairs capacity to be 130, when it is in fact 99 This incident can be found under Madison Police Case # 08-132038

- On May 31, 2008, at approximately 1:02 a.m., Madison Police Officer Carrie Hemming was on routine foot patrol when she and noticed that the upstairs outdoor beer garden area of Johnny O's appeared to be crowded. Officer Hemming went to the upstairs of Johnny O's and counted 176 patrons. Officer Hemming then reset the counter and walked through the upstairs of Johnny O's again and counted 185 patrons. The legal capacity is 99. This incident can be found under Madison Police Case # 08-146715.
- On June 1, 2008, at approximately 12:57 a.m., Madison Police Officer Carrie Hemming conducted a routine tavern safety evaluation at Johnny O's Officer Hemming counted 133 patrons in the upstairs beer garden and the legal capacity is 99. This incident can be found under Madison Police Case 1147821.
- On June 6, 2008, at approximately 12:49 a.m., Madison Police Officer Carrie Hemming. Officer Hemming conducted a routine tavern safety evaluation at Johnny O's. Officer Hemming used a handheld counter to count the patrons in the upstairs roof beer garden and counted 152 patrons. Officer Hemming then reset the counter and this time counted 153 patrons and the legal capacity is 99. This incident can be found under Madison Police Case # 08-153209.

- 5. On April 17, 2009, at approximately Madison Police Officer Carrie Hemming reports that the rooftop deck was over capacity. Officer Hemming counted 122 patrons and the legal capacity is 99. In addition the main bar had a dance floor with a DJ set up on this night and the dance floor area was very congested. The layout of the bar is such that patrons need to pass through the dance floor area to access the bathrooms. Officer Hemming noticed it was difficult for patrons to pass through this area. This incident can be found under case # 09-107038.
- 6. On April 18, 2009, at approximately Madison Police Officer Carrie Hemming reports that the rooftop deck was over capacity. Officer Hemming counted between 169-189 patrons and the legal capacity is 99. This incident can be found under case # 09-108390.
- On April 17, 2009, at approximately 12:53 a.m., Madison Police Officer Carrie Hemming conducted a routine tavern safety check at Johnny O's. As Officer Hemming approached Johnny O's she noticed a crowd of 50 to 75 people attempting to enter Johnny O's. This large crowd was creating a small crush on the front door. There was not a line to enter, instead people were trying to all get into Johnny O's at the same time. Officer Hemming announced to all these people that no one was permitted to enter Johnny O's until a single line was formed. Officer Hemming then went onto the rooftop deck of Johnny O's and counted the patrons. Officer Hemming counted 122 patrons and the legal capacity is 99. This incident can be found under case # 09-107038.
- 8. On April 18, 2009, at approximately 12:53 a.m., Madison Police Officer Carrie Hemming conducted a routine tavern safety check at Johnny O's. Officer Hemming entered the rooftop deck area and used a handheld counter to count the patrons.

Officer Hemming counted 189 patrons and then reset the counter and counted 169 patrons on her second pass through the roof top deck. Legal capacity for the rooftop deck is 99. This incident can be found under case # 09-108390.

NOW, THEREFORE, for all the above stated reasons and pursuant to Sec. 38 10(1)(e), Madison General Ordinances, the complainant requests that the Common Council of the City of Madison non-renew the combination Class B Alcohol Beverage License to sell fermented malt beverages and intoxicating liquors for the premises known as, UNIVERSITY SPORTS INC, d/b/a Johnny O's Restaurant and Bar, 620 University Ave, Madison, Wisconsin.
