We had the property inspected before purchase and the inspector stated that most of the windows were old and decayed and needed to be replaced. Most of the windows will not shut tight and/or do not work. Many of the windows have metal storm windows or half metal storm windows which do not look original to the historic home. The windows are not plum or square which will make difficult to repair.

I called a contractor in Madison to give me an estimate on repairing the windows. I told him that you had stated it would be best for historical purposes and he said the only reason to not replace would be to get the benefit from the tax rebate. He would give me an estimate at \$85 an hour and said with the visit and paperwork it would take at least three hours.
