Updated Entertainment License Application Security Plan

We strive to create a relaxed environment for our patrons to unwind; the goal is to provide, in addition to food, live music as amenity for weekend latenight guests. The entertainment offered on the premises is ambiance-driven live eclectic DJ sets (music genres to be featured-- jazz, electronica, rare grooves, soul and funk, and a multitude of classic music from the 70s to the 90s) that largely appeal to a mature and sophisticated audience; and it is our desire to garner such clientele, one with discerning ear for music and palate for food and beverages.

For DJ events we will have three dedicated security personnel employed inhouse. One is a door person and the other two will be surveying the dining room area. A restaurant manager, servers, and bartenders including a bar manager will also be on the premises to assist with security if necessary.

The security door person will be stationed at the entrance and check identification of each patron entering the premises. The security door person will also manage any lines and keep track of capacity with a counter. The two roaming security personnel will be on the floor observing patron behavior to ensure that guests are conducting themselves properly and deal with any issues.

Door personnel and security staff will be wearing T-shirts and black hats that are company branded with name and logo that identifies them as security personnel.

We will familiarize our security and management staff with the unruly patron ordinance - Madison General Ordinances Section 38.06 (10). When a patron acts in a way that is violent, abusive, indecent, profane, boisterous, or otherwise disorderly, the guest will be asked to leave. If the guest has an issue or refuses to leave, then management will call the police.

For intoxicated guests, Madison General Ordinances Section 38.02 will be enforced. When a guest has been refused service by the bartenders, other employees will be notified. Management will support the bartenders' decision and make sure it is enforced. The guest that has been refused service will be offered a taxi or other safe ride. If guest agrees to the safe ride the employee or management will arrange it. If guest refuse to leave the premises then management will notify the police.

No guests under the age of 21 will be admitted after 10:00 p.m. All government-issued ID's used to prove age must be valid and may not be expired. If the ID used is questionable in any way then a second form of ID will be requested. If the ID is suspicious then the security personnel will ask questions about the information on the ID. If there is strong suspicion that the ID is false then the ID will be confiscated.
