Hello,

My name is Karen Margelofsky-Sorensen and I live at Corscot Court. I'm writing to you as I believe you are part of the Plan Commission (I found your contact info on the City of Madison legislator site) and on May 9 will be hearing the case for the conditional permit for outdoor seating at Monty's Blue Plate on Atwood. I would attend the meeting in person but I will be out of town and am therefore unable to be present.

While I like the restaurant and don't mind them having outdoor seating their use of a loud speaker to call their patrons to their table is getting very old. They do this daily but most extensively on weekends, many times starting at 9 or 9:30 in the morning on both Saturdays and Sundays. If it's a nice day and they are busy these amplified notifications can go on throughout the day. We live about a block away and I have also talked with neighbors of Linden Street which is further away and they too have expressed frustration with the noise and intrusion this frequently causes throughout weekends. And if the neighbors blocks away hear it so clearly and loudly I hate to think of what it must be like to be sitting outside at the restaurant and to have to listen to the amplified "yelling" as people are called. In addition to the hours of "table for 2 for Steve", "table for 6 for Sue", "last call for Barb for a table for 4" there are also times when the staff use this sound system at closing time and have sung songs over the speaker system and in general played around with it to goof around and/or converse with staff who may be cleaning up outside. Many restaurants give their patrons a silent pager that goes off when a table is available and this

would be a most welcome system for Monty's to use as it would cause no intrusion of sound noise on the environment of the neighborhood, in our homes, and in our backyards when we are trying to enjoy our time outside. Even though the neighborhood is active it can be quite quiet and lower key on weekends and it is nice to be able to have windows open in spring, summer and fall. However, the barrage of business related noise from their use of an amplified speaker system is very trying and not conducive to enjoying our neighborhood and personal environment. I don't know if there is anything you can do about this as part of their permit but if there is and this level of noise intrusion and interruption in our neighborhood, especially on weekends, could be addressed and stopped it would be most appreciated.

I will be out of town and off the grid for much of the time between now and the meeting so will have very limited access to technology and email. But if I can provide any further info please let me know and perhaps I will have a chance to respond before 5-9.
