Construction

Capitol Square – The Saturday food court is going well and those food vendors not involved in it seem satisfied with their circumstances. After five Saturdays, Arts & Crafts Vendors have started to become accustomed to the intrusive construction equipment,

fencing, mud, etc., and have settled into the improvisational environment that changes a little every week.

As of Saturday, July 16, most Arts & Crafts vendors were able to return to their regular sites.

Saturday Food Court – Some food vendors have elected to stay in the food court for the remainder of the season. Other vendors will return to regular Saturday food vendor sites over the next week or two.

## 700 Block of State Street (a.k.a. The Library Mall)

Several food cart sites were lost to the demolition and reconstruction of the Catholic church. Vendors are becoming accustomed to their new 2016 sites and to the repositioning of some carts to newly created temporary sites.

# MG&E Construction Prolonged Due to a Strike

A man hole connected to church plumbing is immediately adjacent to a food cart site on the north side of the 700 block of State Street. As a result, two more carts will be displaced for about a month starting on Monday, June 13th.

In reality, several more 700 block carts were displaced by this project that turned out to be much more extensive than originally described and which was supposed to have taken about a month. The project is now on hold, continuing to disrupt normal, everyday life on the 700 block. It is not known how long this will go on.
