Hi Rob,

Items 10 and 12 on the BPW Agenda are for amendments to existing licenses to Sprint and AT&T, respectively, which grant each company the right to place telecommunications equipment on the City-owned Lake View water tower (along with equipment shelters on the land near the tower base). The licensees have been operating from a temporary monopole while a new water tower has been constructed. These amendments allow the licensees to reinstall their equipment on the new tower. The licensee will have a 90-day installation time period beginning on 11/16 to install equipment on the new tower, with additional time for site restoration and monopole removal (restoration deadline in 6/1/17). The amendments also provide the licensees with four (4) additional five (5)-year renewal options.
