Glenwood Childrens' Park Revised Implementation Schedule

East Slope Restoration Project Scope of Services for Ray Murphy / Vanaheim Landscaping November 2016 - August 2017

The East Slope Restoration Project is mitigating a steep, potentially highly erodible area in Glenwood Park where the current adopted woodland management has prescribed tree removals which were completed Spring 2016 by Madison Parks & Forestry.

DMNA has raised funds to stabilize and restore this slope area under a Landscape Plan and techniques that utilize the felled tree limbs, logs and brush to create a surface stabilization structure that is intended to decayin-place while native plantings are established. DMNA has interviewed potential contractors to assist with this site work and intends to hire Raymond Murphy / Vanaheim Landscaping to carry out the work.

No mechanized or heavy equipment shall be entering the park to carry out this work. The limbs being used are manageable by hand and are being deployed downhill into the slope from Glenway Street delivery by Madison Forestry crews as needed to complete the surface stabilization structure.

As per the Glenwood Childrens' Park Urban Forestry Management Plan, adopted by the Madison Parks Commission at the Board of Commissioners meeting on June 12, 2013; as well as prior meetings and documents with Madison Parks staff, the following site work shall be included in the East Slope Restoration Area which is part of Management Unit 2 of the Forestry Management Plan:

Scope of Services

- 1: Removals of Black Locust suckers & other undesirable small caliper species in "East Slope Restoration Area" In general removals are not being dug/grubbed out; but cut and treated with systemic herbicide leaving root systems in place to not disrupt existing soil conditions and create more erosive conditions.
 - Raymond Murphy/ Vanaheim Landscaping has a valid herbicide applicators certificate: WI Dept of Agriculture, Trade & Consumer Protection License #284703 Expiration date 10/31 2017. See attached.
- 2: Installation of logs, limbs and "brush bundles" by chainsaw cutting and fitting of the supplied downed tree materials as per the plan using stumps of prior tree removals as the principal anchorage points.
 - Raymond Murphy/ Vanaheim Landscaping has certification in chainsaw safety field training covering OSHA 1910.266 Rules & Regulations completing level 2 from Forest Safety Instruction. See attached below.
- 3: Facilitate chainsaw brush processing as needed for a series of overwinter workshops with volunteer Scout & Student volunteer groups currently being trained in creating "Brush Bundles". So far two groups representing 75 scouts and students, and 15 teachers and other adults have participated in 2 workshops.
- 4: Installation of biodegradable erosion fabric, mulch & associated gradework in between the installed logs, limbs & brush bundles as needed.
- 5: Installation of cover crops, native seed, & plants as needed.
- 6: Follow-up herbicide treatment of Black Locust suckers from existing roots through August 2017
