The City of Madison is proposing to resurface a portion of Langdon St. in 2017. Enclosed with this letter is a fact sheet with some details on the proposed project, which includes a map of the proposed project limits. Also enclosed is a notification for the Public Hearing before the Board of Public Works. The date, time and location of the public hearing can be found on the notification.

December 19, 2016

This project will involve special assessments to the owners of property adjacent to the project. The property owners will be assessed for various items included with this proposed project, and the costs of some of those items are assessed entirely to the owner. A table detailing the City's standard assessment policy for the items of work is included on the fact sheet.

The Schedule of Assessments is enclosed, which shows the estimated costs for each property adjacent to the project. After the work is complete, a final assessment will be calculated based on bid prices and work actually performed, and the final assessment will be billed during the following summer. The final assessment is payable in one lump sum or over a period of 8 years, with 3% interest charged on the unpaid balance.

Please note that some of the properties included with this project appear to have 2 sewer laterals, and this is reflected on the schedule of assessments. This is based upon what the City has for utility records and what our sewer television reports have shown. The City's contractor will only reinstall the laterals that are actually determined to be being active, and this verification will be done during construction. The final assessment will reflect the actual amount of lateral(s) installed.

This includes requests relating to the Public Hearing and also requests relating to the actual operations of construction. Fact and Details Sheet

Proposed 2017 Langdon St. Resurfacing & Utility Replacement Project

Project Details - Proposed Work

Sanitary Sewer: Replace existing main (installed in 1969) on Langdon St. between Lake St. & Frances St., and replace laterals (*assessable*) to the property line, which is on the building side of the sidewalk.

Water Main: There are two existing water mains on Langdon St.; one main is from 1882 and the other is from 1984. Any services currently connected to the 1882 main will be disconnected from that main and reconnected to the 1984 main. No water main replacement is currently expected. If there is a possibility of future building renovations or redevelopment see more information regarding your water service on reverse.

Storm Sewer: There is currently minimal storm sewer located between Frances St. & Carroll St., so new storm sewer will be installed on those blocks. Any curb scuppers (private storm sewer connections at the curb for roof drains, etc.) will be connected to the new storm sewer per City standards (*assessable*)

Street Lights: Install new pedestrian lights where no pedestrian lights exist (*assessable*), which is in the area east of Henry St. (starting at about 133 Langdon) up to Carroll St. The style of the pedestrian lights will match what was previously installed on Langdon St. Existing mid-block street lights in this area will be removed, but all existing lights at intersections will remain.

Street: Replace the asphalt pavement (*not assessable*) and replace curb, driveway aprons, and sidewalk only as needed (*concrete items assessable*) to repair damaged sections or as necessary for utility and lighting work. Replace the pavement markings; no changes to the street widths or lane configurations. The street grade will be changed around the large curve on Langdon St. to help flatten terraces and steep driveways, and, similarly, the street grade on the north side of Langdon St., east of Henry St., will be improved to eliminate the second curb (step in the terrace) and to flatten driveways in that area.

Terraces: In recent years, the terraces on Langdon St. from Lake St. to east of Henry St. were replaced with exposed aggregate concrete. If any of these newer terraces are replaced for utility work or street grade changes, those replaced areas will not be re-assessed. From east of Henry St. (about 133 Langdon) to Carroll St., the terraces will be replaced with new sod (*assessable*). From Lake St. to the west (where the UW Memorial Union project ended), the existing terrace pavers will be replaced with new pavers to match the Union project (*assessable*).

Trees: At this time, there are 3 planned tree removals with this project, and are located at these Langdon St. addresses: 120, 126, and 221. Prior to construction, City Forestry will prune the trees to provide adequate clearance above the street, and the site will be reviewed following the project for potential planting of new street trees.

Construction Schedule & Impacts

Tentative Schedule: May 15, 2017 until mid August 2017 (approximately 3 months)


Traffic Impacts: Langdon St. between Lake St. & Frances St. will be closed for approximately 1 month for new sewer main construction, and the remainder of the project is being reviewed to possibly maintain 1 lane of traffic, one-way, during construction. At minimum, local & emergency access will be provided during construction, but access to driveways being replaced may be closed for concrete replacement work. There will be no parking allowed on Langdon St. during construction. Pedestrian access will be maintained on at least one side of each of the streets at all times, and will be open to all properties where needed.

Water Shut-offs: An average of two water shut-offs are expected for each property with a water service on the portion of the water main that is to be replaced. The timing of these shut-offs will be coordinated as much as possible. A minimum of 48 hours of notice will be provided prior to the shut-offs. Each shut-off may last up to 8 hours, but typically last about 4 hours. There may be emergency shut-offs if the old, brittle main is damaged during construction before all properties are reconnected to the newer main.

Refuse & Mail Collection: Refuse and mail collection will continue as they typically do, and the contractor will be required to provide that access. Please mark your address on your carts before the start of construction in case the contractor moves the cart for collection.

Potential Water Service Upgrades: If any property owners are considering future building renovations; alterations or additions; occupancy changes; or development to properties, the installation of a fire sprinkler system may be required. Therefore, please consider increasing the size of a property's water lateral during this project. If property owners change the size of water laterals during this project, while the street is already dug up, it will likely save significant costs versus doing the work post-project. Interested property owners should contact the Madison Fire Department with questions about the need for additional fire protection. To coordinate upgrading water laterals to any property on this project, contact the project water designer as soon as possible.
