The following provides an illustration of what would be available at each fare level under the scenarios previously presented. Please note that while there was some discussion under the concept of a Premium fare to offer expanded services, they have been excluded from the information below. The intent is to address our current offerings rather than expand on them.

## Scenario 1 – Status Quo
