Sanitary sewer connection charges levied by the Madison Metropolitan Sewerage District (MMSD) for these lands shall be deferred until such time as the lands are subdivided, developed and require sanitary sewer service. The base rate shall increase annually as determined by MMSD and the final connection cost will be determined by MMSD. Final billings will be generated by MMSD at the time of development or connection.

(2) Sanitary sewer and storm sewer improvements are assessed 100% by lot area. Area values of lots already served by sanitary sewer not included in assessment calculation

(3). Property will be subject to the Elberberry Neighborhood Sanitary Sewer Improvement Impact Fee which will be deferred until the property is developed and/or requires sanitary sewer. Impact Fee will be based upon final platted area or unplatted lot area at the time of connection. Impact Fee

rate will be increased annually by the Construction Cost Index (CCI).
