I am representing SSM HEALTH who is the new brand for what was Dean - currently in the building space at the above address. SSM HEALTH would like to install 3 similar type wall signs on the 3 designated wall spaces on the south elevation. The proposed signs for these designated areas are within the guidelines of the current sign code as far as size of sign in proportion to the sign-able areas. The issue is, however, that there would be 3 total wall signs on a single elevation. The building structure was designed to have multiple tenants and multiple signs. SSM HEALTH leases a majority of the building and their space spans what would be several tenants. Despite that the lease space falls under one leasee, there are different entities facilitated in the space. Those include SSM HEALTH Human Resources, SSM HEALTH Therapy Services & SSM HEALTH Administration. SSM HEALTH would like to be able to install signs that would identify the corresponding areas of this leased space. In addition to the wall signs, we have proposed for 3 door identifying structures under the canopy. These structures are not defined within the current sign code as to their type. They have been designed to serve as wayfinding identifiers in text and in color as SSM HEALTH ministers to many people who may not be able to read or be able to see well enough to read.

We are seeking a Comprehensive Design Review approval for there to be 3 sign-able areas on the south elevation for the same tenant and for the allowance of the proposed under canopy structures.

All proposed wall signs will fit within the guideline of the current sign code in regards to sign size in relationship to the sign-able areas.

This does not violate any purposes described in the current sign code.

All signs will meet or exceed minimum construction standards per the current sign code.

All proposed signs will not present a hazard to vehicle or pedestrian traffic, obstruct views to at points of ingress or egress of adjoining properties, obstruct or impeded visibility of existing lawful signs on adjacent properties, or negatively impact the visual quality of private or public "open space".

All proposed signs are located within the zoning lot and do not extend into public property or right of way.
