d. Biergarten at Olbrich Park Beach Proposal

Mike Bare from BKM Group LLC outlined the proposal of a Biergarten in Olbrich Park near the beach house. He noted that the Milwaukee area has 4 of these venues that are operating successfully. Milwaukee opened its first biergarten in 2012 and there are two "permanent" biergarten's and two that "travel". The organization would use the beach house and an area adjacent for the Biergarten. The beach house would also be used by Rutabaga for boat rental, paddle boats, etc. The space does not have a designated use in the Olbrich Park Master Plan.

The proposed improvements include \$47,500 of capital improvements (clean, paint, upgrade bathrooms, upgrade electrical, repair roof/walls, install seating area, etc..) and additional bike racks. The Biergarten would be open seasonally in accordance with the City Parks spring and winterizing schedule, which is @ May – October, weather depending. The last call for beer purchases would be at 9 pm and the park closes at 10pm. The owners are local and plan to hire an operating manager. All staff would be age 21 or over. The menu would include beer, sports drinks, water, pretzels, mini-brats, potato salad and rules would be posted (no carry in of alcohol, no unaccompanied minors, no grills, no smoking) but customers would be allowed to bring picnics.

At this point BKM still needs the following: parks vending permit, liquor license, restaurant health permit and a building permit. Additional information:

- size = @ 5800 sq ft, but not specifically determined at this time
- would like live music (performers, but not rock concerts)
- plan to be open for 2017
- 270 person capacity
- open 7 days a week
- There are 120 parking stalls in the beach parking and 170 stalls across Atwood at the ball diamond parking lot

Board members raised concerns about the name -- as Olbrich Biergarten – people think it is at Olbrich Gardens. It was suggested that Olbrich "Beach" be in the title to help visitors know where they are going.

B. Financial Report

a. November 2016 Financials

Ms. Phillips noted that revenue and expenses are trending consistent with 2015. Net income is about \$40,000 YTD.

Revenue: Leaf Mulch revenue has been removed

Gift Shop revenue increase is reflected (based on 2015 actual)

Expenses: the largest line item is wages and benefits and this budget includes a 3%

increase for most staff

A motion was made by Mr. Sherry and seconded by Mr. White to approve the 2017 OBS Operating Budget. It is noted that the last column should be titled "% change from 2016 approved budget to 2017 proposed budget". Motion carried unanimously with the change noted.

C. Director's Report

Ms. Sladky reviewed staff reports. Attendance continues to trend higher, although December and the Train Show attendance have been lower due to extreme cold and snowy weekends. The UW has reached out to us to work with a visiting artist for an installation at the Gardens. The City of Madison has not finalized an architect. City engineering staff are reviewing the proposals and will finalize the selection this month.

D. Development & Marketing Staff Update

Joe Vande Slunt notes that Olbrich is behind in overall appeal responses, but have received a great response for December to date. There is a lot of interest in the Tribute Trellis so two more leaves will be added. To date 131 gift memberships have been purchased.
