STEP 5—SAFETY AND SECURITY

I. GENERAL

The "Orton Park Festival" will be held from August 24-27, 2015 at Orton Park, Corner of Spaight St and Ingersoll St.

II. PURPOSE

- **A.** This emergency action plan predetermines actions to take before and during the "Orton Park Festival" (hereinafter referred to as the event) in response to an emergency or otherwise hazardous condition. These actions will be taken by organizers, management, personnel, and attendees. These actions represent those required prior to the event in preparation for and those required during an emergency.
- **B.** Flexibility must be exercised when implementing this plan because of the wide variety of potential hazards that exist for this event. These hazards include, but are not limited to, Fire, Medical Emergencies, Severe Weather, or situations where Law Enforcement is required.
