May 23rd, 2017 **AGENDA ITEM** MEETING DATE ITEM Adult School Crossing Guards **ID Number** Council report back due date: none none OTHER REFERRALS AND ACTIONS TAKEN TO DATE: (Asterisk indicates lead agency.) none STAFF DISCUSSION OF ITEM: At the request of MPD, TE has undertaken a review of the 2016-2017 school year Crossing Guard Placement. TE Staff met with the Crossing Guard Supervisor to discuss program operations. TE Staff were requested to review seven Adult School Crossing Guard assignments for possible discontinuance. MPD requested this due to the number of elementary school students using the crossings having dropped below the threshold of 15 for several years. Traffic Engineering contacted school principals, parent teacher groups, Neighborhood Associations, Alders and School Traffic Safety Committee to communicate the determination to study the Adult School Crossing Guard assignments for discontinuance. Traffic Engineering offered assistance to help the school community increase the number of elementary school students walking to school to retain the Adult School Crossing Guard assignments. Traffic Engineering staff conducted studies at each of the requested locations in the fall and spring during days of regular school schedule. Results of these studies are included in the attached worksheets and recommendations are based on the adopted School Crossing Protection Criteria. The criteria are available at http://www.cityofmadison.com/trafficEngineering/documents/SchXngProtectCriteria2016.pdf FISCAL IMPLICATIONS: The cost of an Adult School Crossing Guard per year is \$8,900; this includes salary, benefits and uniforms. The discontinuance of an existing Adult School Crossing Guard assignment will reduce MPD's budget by this amount. Recommend maintaining Adult School Crossing Guard assignments at the intersections of Old Middleton & Rosa and Fair Oaks & Lexington as these locations meet the criteria to maintain the Adult School Crossing Recommend Traffic Engineering review signing and marking in the vicinity of locations recommended to discontinue Adult School Crossing Guards.
