MALL/CONCOURSE FOOD VENDOR STATUS

Licenses Issued in 2017: 30 with 21 in progress

Licenses are continuing to come in and I am making notes on what can be done to help the process be smoother and user friendly next season. There continues to be issues with the platform we are using to license. I am working regularly with IT to address these challenges on both my end and on the vendors end.

SIDEWALK CAFÉ STATUS

MISCELLANEOUS

• The new location of vendors on the 200 block of MLK is going very well. Vendors are happy with their sales and the customers I am talking to like that the carts are now closer to their office. I would encourage the VOC to consider continuing to have carts there after construction of the square until the Madison Municipal Building's (MMB) construction is complete. I would also ask that the VOC consider allowing a limited number of carts there after the MMB is back in operation

The Wednesday relocation due to the Farmer's Market seems to be working. We have blocked off meters on Doty St. for cart to park and relocated two vendors in front of the soon to be Belaire. They will stay there until the restaurant opens or construction is over. Whichever comes first.

- The BID is putting out bistro chairs during the lunch hour (11a-2p) at the top of State St. in Philosophers Grove area. It has been off to a good start. We encourage you to visit or schedule a meeting. Their programming has also recently started. We are working on a plan to relocate vendors based on their events.
- I recently met with an entrepreneur that is interested in creating an app for food carts. He walked us through his initial ideas and showed some screen shot

- examples. It would be a platform for people to place an order and schedule a time for pick-up. It would also have a way for customers to search for locations of carts.
- I am continuing to get more and more businesses requesting food carts over the lunch hour. They are in many different areas of the city. I continue to work with them to outreach to vendors and determine if the space is appropriate for that type of vending.
- Construction on the square is moving forward but continues to create challenges for vendors and required me to create temporary placements of vendors to accommodate parts of the construction project.
- The Madison Sports Commission and the Greater Madison Visitor's and Conventions Bureau in partnership with the City of Madison and the UW as well as many other partners have launched "Bucky on Parade". It will be similar to the "Cow's on Parade" a few years ago. There will be 100 Bucky's decorated by local artists and groups and placed around Madison. I am sitting on the planning committee to make sure the locations will not affect vendors in the downtown area.
- I have been meeting with many departments regarding Crazy Leg's Triangle and the reconstruction of the area. We are looking at how to create a gathering space with amenities and vendor friendly design. There will be some work by MG&E this summer but it will be done before the football season begins.
- I continue to have conversations about allowing full sized food trucks and vending on private property on a daily basis.
