I first learned of the July 14th TORC meeting on Wednesday evening at the TPC meeting. Since I had already scheduled a prior commitment in Middleton for this afternoon, I am unable to attend the TORC meeting today. So I have reviewed the most current revisions in the documents distributed, and I have prepared some comments to share with the group.

- Since there may be some items which might need to be addressed by the Transportation Policy and Planning Board which are not detailed in 33.55, I suggest you consider adding to section (6) on <u>Powers and Duties</u> an item (i) to read something like: "Address other items as referred by the Common Council, Transportation Commission, Director of Transportation, Traffic Engineer & Parking Manager, or Transit Manager."
- In 33.56 on the Transportation Commission, please consider adding "Director of Transportation" as a potential referring party for other items in sections (5)(a)(10), (5)(b)(5), and (5)(c)(9).
- In section 33.56 (3)(a) on the <u>Commission Composition</u>, why is parking knowledge not included as a preference for additional remaining resident appointments? I believe parking to be an important priority in the City, as well as transit and bicycling.
- In order to promote good communication on important issues, I would encourage that periodic joint meetings of the Board and the Commission be held as appropriate.
