NOW, THEREFORE BE IT RESOLVED that the Common Council hereby authorizes the Mayor and City Clerk to enter into a contract for Purchase of Services (Architect) in a form to be approved by the City Attorney, with TBD Architects, Inc. to provide professional architectural/engineering design services and construction administration services for the Public Health Offices Remodel.
