MGO 34.604 EMERGENCY AND STANDBY POWER SYSTEMS - (2) IFC section 604.2.14.1.1, the exception for the use of pipeline natural gas as the fuel supply for the generator is not included as part of this code

2. The rule being petitioned cannot be entirely satisfied because:

Natural gas feeding a emergency power system is not allowed per MGO 34.604. The building owner would prefer that the generator be natural gas as it also provides standby power for their network room.

3. The following alternatives and supporting information are proposed as a means of providing an equivalent degree of health, safety, and welfare as addressed by the rule:

Generator would be fed with its own dedicated natural gas line, labeled every ten feet, provided dedicated shut offs / labeling for each line, there would not be any ties in to the line that serves the generator.

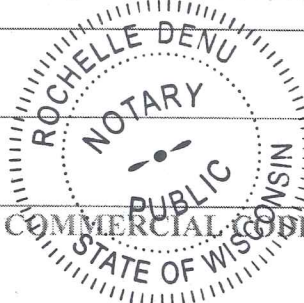
