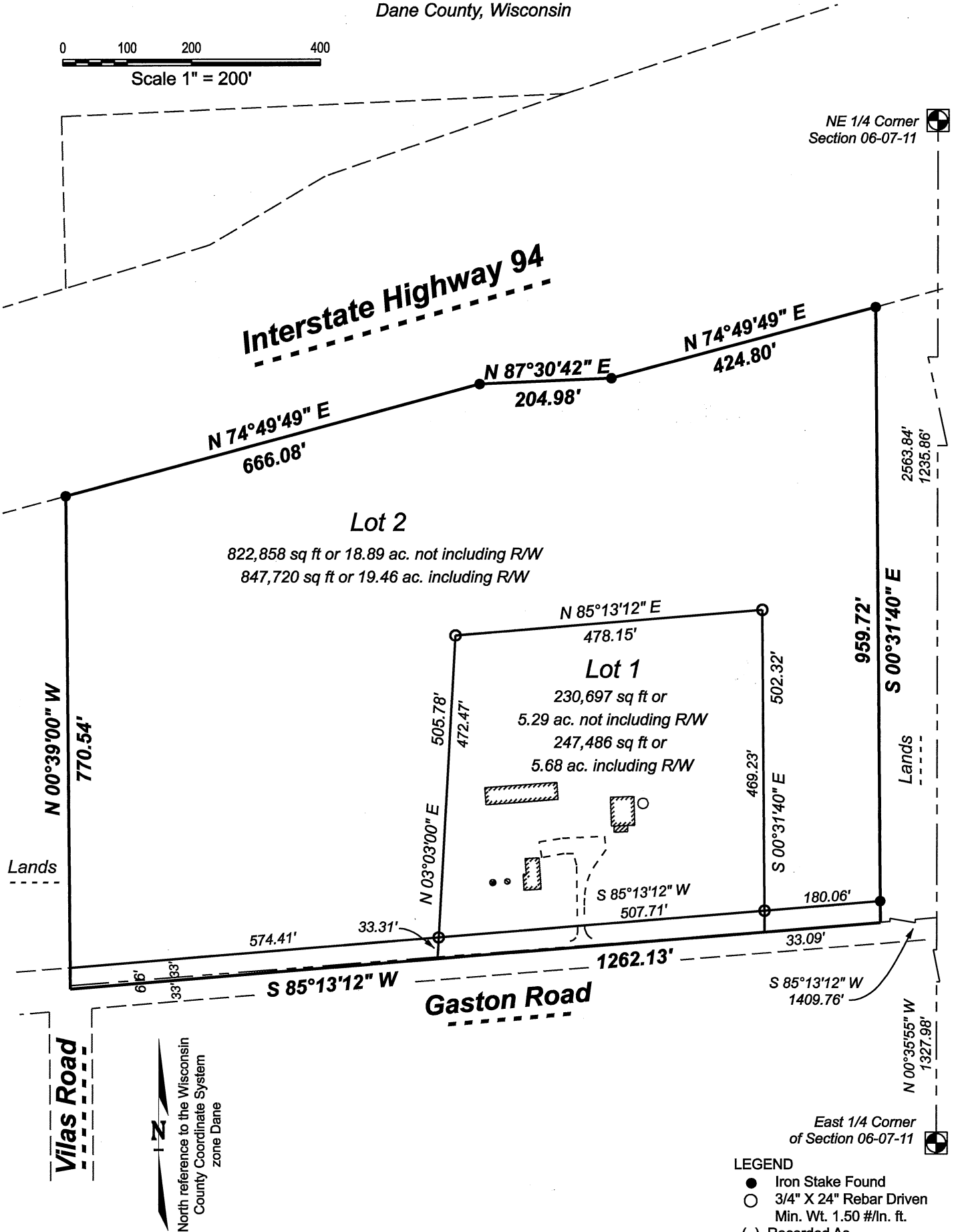
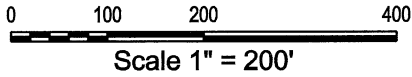

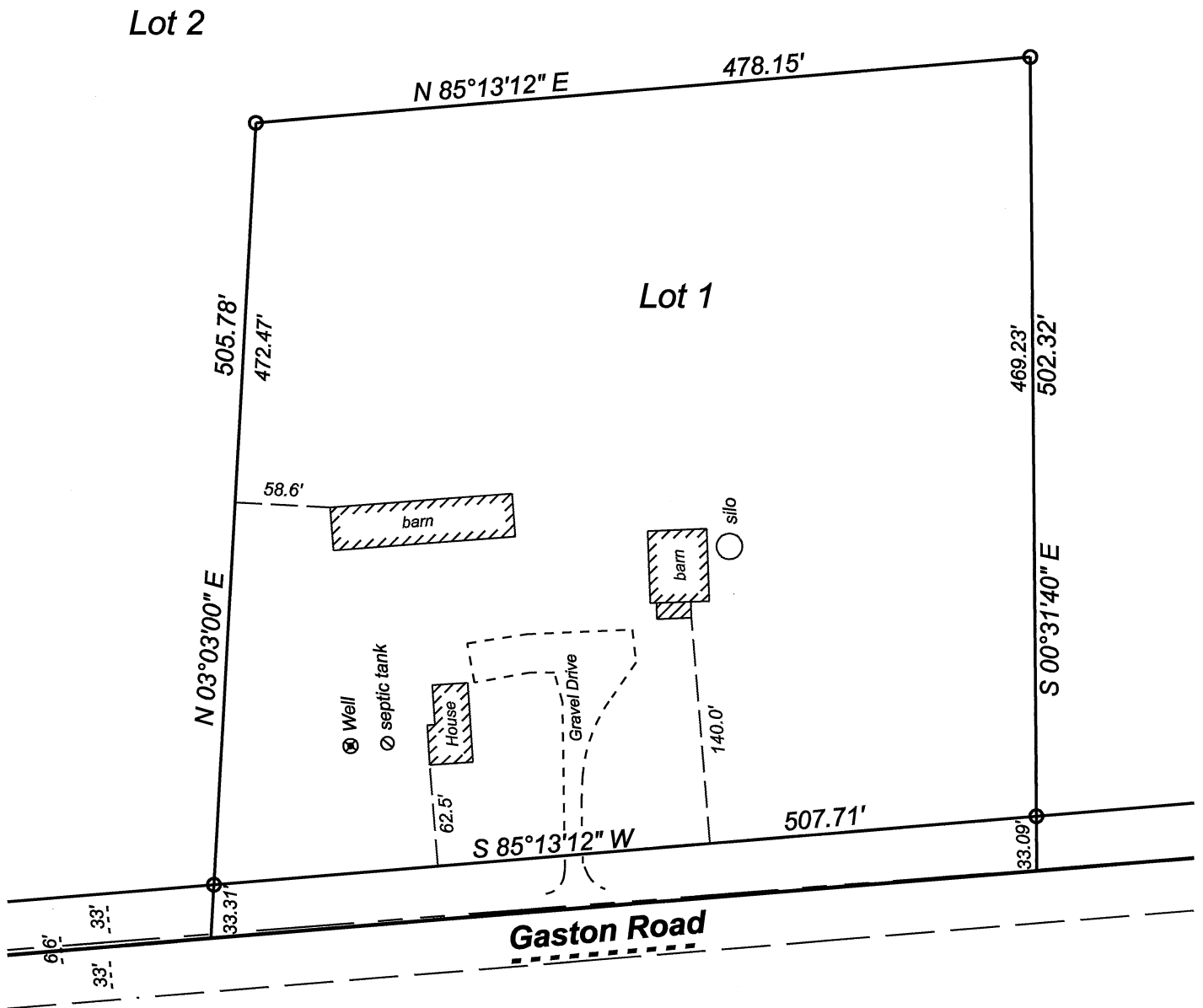

Commencing at the East 1/4 corner of said Section 06;
Thence N 00°35'55" W, 1327.98 feet along the east line of the Northeast 1/4; Thence S 85°13'12" W, 1409.76 feet to the point of beginning of this description; Thence continuing S 85°13'12" W, 1262.13 feet along the centerline of Gaston Road; Thence N 03°39'00" W, 770.54 feet along the west line of the northwest 1/4 of the northeast 1/4 to the southerly right of way of Interstate Highway 94; Thence N 74°49'49" E, 666.08 feet along said southerly right of way; Thence N 87°30'42" E, 204.98 feet along said southerly right of way; Thence N 74°49'49" E, 424.80 feet along said southerly right of way; Thence S 00°31'40" E, 959.72 feet to the point of beginning of this description.
