

**LEGISTAR #50708 - Body**

DRAFTER'S ANALYSIS: This ordinance prohibits any owner or keeper of any animal from permitting the animal to run at large within the City. It moves the prohibition against keeping pigs to a new section and creates a process for allowing such animals when at a special event at a park or street use event. It also establishes a bail deposit for possessing a pig within the City.

The Common Council of the City of Madison do hereby ordain as follows:

1. Section 23.31 entitled "Animals Not to be Permitted to Run at Large" of the Madison General Ordinances is hereby amended as follows:

**"23.31 ANIMALS NOT TO BE PERMITTED TO RUN AT LARGE.**

- (1) ~~Notwithstanding Sec. 23.32, it shall be unlawful for the owner or keeper of any animal nonhuman, warm-blooded, vertebrate or reptile to permit the same to run at large at any time within the limits of the City of Madison.~~
- (2) ~~No person, firm or corporation shall keep, harbor, or have in their possession, custody, or control any pig, hog, boar, or swine within the limits of the City of Madison provided, however, that the prohibition contained in this section shall not apply to operators of slaughterhouses or packing plants, and areas zoned "Agricultural."~~

2. Section 23.52 entitled "Possession of Pigs Prohibited" of the Madison General Ordinances is created to read as follows:

**"23.52 POSSESSION OF PIGS PROHIBITED.**

- (1) No person, firm or corporation shall keep, harbor or have in their possession, custody or control any pig, hog, boar or swine anywhere within the limits of the City of Madison.
- (2) Exceptions. This section does not apply to the following locations and circumstances:
  - (a) Within the confines of an event for which a park event permit, neighborhood association park event permit, or any other permit for activities taking place within a City park has been issued by the City, if the presence of the animal is noted as a condition of issuance of the permit.
  - (b) Within the confines of an event for which a street use permit or neighborhood block party permit has been issued under Sec. 10.056, MGO, if the presence of the animal is noted as a condition of approval of the permit."

3. Subdivision (a) of Subsection (3) entitled "Schedule of Deposits" of Section 1.08 entitled "Issuance of Citations for Violations of Certain Ordinances and Providing a Schedule of Cash Deposits" of the Madison General Ordinances is amended by repealing and creating therein the following:
