## **Entertainment License (21+) Security Plan for Cowboy Jacks Madison**

#### Introduction:

We want to make life better for people whether it is providing a place to have some fun, improving someone's day/night, helping someone out, or just in general making a positive impact. That's what motivates us to keep pushing ahead. We love what we do and are always striving to get better and be the best at what we do.

One of our goals is to continue to provide a place for people to excel. Also, just as important is for us to provide an environment that fosters change and growth in us personally and professionally. So far, we have had an amazing journey and have had the good fortune of taking that journey with some of the most wonderful and talented people in the industry. We cannot wait to see what our next chapter will be

- 1. Our premises will offer the live band or DJ music over the weekends after 10pm. We take security measures for the guests, employees and the surroundings areas, very serious. Cowboy jacks will hire private company to do security measures of the premises. Premises has of total 4 exits and at each exit, there will be a security guard to monitor each exit and the traffic. The entrance to the establishment is in the middle of the restaurant building. We will employee an ID monitor who would scan ID's digitally to track each and every one inside the establishment.
- 2. Establishment owns the parking lot. It has 2 major entrances to the parking lot from John Q hammons drive and Damming way. Parking lot will be monitor by security cameras. Entrances line will be managed by dedicated security. Each id will be scanned digitally to avoid or to catch fake ids or underage patrons. In case of emergency contact will be 911 services. We would also have non-emergency number of police department. We will make sure we keep a healthy environment for customers and community. Making sure we and the customers are respecting the cities laws and orders. As well with closing bar at 1:45AM and with turning lights on to get customers time to prepare themselves to leave our self-time to identify which customer will need transportation making sure the customers leave in a secure way. We will have contract in place with local taxies services to be at the establishment during the events time. To reduce any

inconveniences or crating any problems to the business, to our community, or to the police department, we will make sure that we take all security measures very seriously

- 3. All the security personnel will be wearing designed security logo on their uniform on front and back of their shirts. It will be easy to identify as security. All other staff will be in Cowboy Jacks logged uniform. Establishment will also use the radio service to relocate each and every security and staff member during the event. There will be between 1-3 employees on site during hours of operations who are responsible for limited food and service and bar management.
- 4. Security and cowboy jacks staff will be trained to monitor doors and premises to prevent the underage, intoxicated and unruly patrons from entering. Staff will also train to notify management of any possible problems with customers. Before the live entertainment or 10pm each and every one from the customers will be id to prevent minors or underage to roaming in premises by security guards.

Bartender will be train to do proper pouring in oz. Bartender and servers will also train to keep close eye on people who will be consuming alcohol that either they are in group or individual person and would know when to stop serving alcohol to them. We are committed to run clean business with little or no issue requiring police and fire intervention. However, staff will be train in what types of situation require a call to police, fire or other emergency services.

Note: Cowboy jacks is applying for the liquor license. It has not opened as business neither employee any staff member yet.
