## Summary of Licenses Granted and Issued

The City of Madison has a quota of 449 Class B Combination Liquor \& Beer licenses under state law. There are 35 Class B Combination Liquor \& Beer licenses available under this quota. The city has issued 89 of its 124 Reserve licenses and 325 of its 325 Grandfathered licenses. The city has issued 133 Class A Beer, 80 Class A Liquor, 119 Class B Beer, 414 Class B combination, 98 Class C Wine and 19 Class A Cider licenses.
