### UFA SECURITY PLAN 5018 Blazing Star Drive, Madison, WI 53718

#### **BACKGROUND**

United Football Association (UFA) is an indoor soccer field that provides recreation opportunities for Madison area soccer enthusiasts since 2013. Its season is from the middle of September through the winter month to end of May. UFA is seeking opportunity to generate revenue during the end of the season (May) and through the off-season from June through the beginning of September. UFA also has a restaurant that serves cooked food and beer for spectators and players alike.

UFA is planning to offer a Karaoke Night and other music venues, once a week from spring through the first half of September. UFA may decide to increase or decrease the Karaoke Night / other music venues based on demand. For Karaoke and Dance Night, there will be a DJ that will supply the sound system and UFA will also have a dance floor for participants to dance while listening to music. Other events may also be music entertainment with a DJ or live band. UFA will also have food and beer available for purchase by customers.

#### Security Plan

- A. In the event UAF conducts a Karaoke Night or other entertainment venue there shall be a minimum of 1 uniformed bi-lingual Spanish speaking security officer. Security officers will be uniformed (police like attire) and used for Crowd Control, Age Verification and head counting duties.
- B. At the end of the evening, all of the security personnel assigned to the event shall report to the parking lot to establish a uniformed presence and maintain order. Security officers will be utilized in the manner that encourages patrons to leave in a safe and orderly manner.
- C. Unruly patrons will be asked to leave the premises and escorted out by a uniformed security officer. In the event an unruly patron commits an act of aggression or destruction of property the security officers will contact the City of Madison Police Dept. and request an officer to respond and conduct an investigation.
- D. UAF will not serve alcoholic beverages to intoxicated patrons and in the event someone is intoxicated beyond caring for him / herself –the security officers will make certain that the individual leaves the premises in a manner that will not enhance public safety.
- E. Security Officers will be responsible for age verification and identifying persons who appear to be under the age of 30. Patrons who produce an identification that is questionable—the person shall be turned away. In the event, the security officer can establish that the patron is attempting to use an altered or false identification card, the security officer shall confiscate the identification card and prepare a written report and forward said report and identification card to the Madison Police Department via U.S. Mail.

- F. The security officers shall contact the Madison Police Department for a response when (1) a patron makes the request (2) when there is an unruly patron who meets the criteria as defined above and (3) when a crime has been committed.
- G. Physical fights in large part will be handled on a case- by- case basis based on the number of persons involved. In each case when there is a crime committed security officers shall contact the Madison Police Department for an investigation.
- H. UAF shall prepare and submit a written roster of employees assigned for alcohol related serving or working in a setting.
