Stats., notice is hereby given that a proposed ordinance, amending Chapter 20 entitled "Impact Fee Ordinance" of the Madison General Ordinances to impose sanitary sewer impact fees upon new or expanded development in the West Elderberry Neighborhood Sanitary Sewer Improvement Impact Fee District and to impose drainage improvement impact fees upon new or expanded development the Bear Claw Way Drainage Improvement Impact Fee Zone and the Mineral Point Road Drainage Impact Fee Zone of the Westside Drainage Improvement Impact Fee District in order to require developers to pay a fair proportionate share for new, expanded, or improved capital public facilities necessary to accommodate new or expanded development within the City, will be considered by City of Madison Board of Public Works, at a regular meeting to be held Wednesday, July 11, 2018 at 5:30 P.M., in the City-County Building, 210 Martin Luther King, Jr. Blvd., Room 108, and that the City of Madison Board of Public Works will then and there consider said ordinance and will hold a public hearing to hear all persons interested, or their agents or attorneys, concerning matters contained in said ordinance, and other action as the City of Madison Board of Public Works may deem proper.
