

**Applicant's Comments**: 122 State Street Group LLC is proposing to redevelop the existing buildings at 122 and 124 State Street and portions of the existing buildings at 118 and 126 State Street for a 130-room hotel. The new building would incorporate the facades and portions of the existing structures at 118 and 126 State Street.

**Staff Findings**: This building was constructed in 1917 and served as the YWCA. While likely significant to women's history, the exterior alterations that were undertaken in the 1970s have severely damaged the exterior of the building.

**Applicant's Comments**: 122 State Street Group LLC is proposing to redevelop the existing buildings at 122 and 124 State Street and portions of the existing buildings at 118 and 126 State Street for a 130-room hotel. The new building would incorporate the facades and portions of the existing structures at 118 and 126 State Street.

**Staff Findings**: Boelsing building (in the Queen Anne style), 126 State Street, 1907. The two-story bay is flanked by columns in the brick wall to either side and a very wide classical entablature with a rounded pediment above. When the building was first constructed, J.F. Schadauer operated a crockery store there. In 1924, it became Clark's men's clothing store.
