To the Landmarks Commission,

We have been engaged by Ms. Kathleen Twist of the above referenced property address. The purpose of this engagement is for the re siding of her home at the above referenced address.

The project will involve the removal of all existing siding and trims on the home. It is the intent of all parties that the replacement material will be James Hardie Fiber Cement.

Lap Siding in a 5" face reveal and of smooth texture as to mimic the current (presumed original) lap siding. Color to be James Hardie Colorplus "Deep Ocean".

Trim boards will be James Hardie 5/4" thick and of smooth texture. Widths will be sized to exact current dimensions on home. See supporting layout. Color to be James Hardie Colorplus "Arctic White".

The base band will be replicated using James Hardie smooth trim and historic Drip cap.

The frieze board at the eaves will be James Hardie Historic 3.25" Crown molding.

There are 2 additions/deviations from the current trim layout being requested. The first, would be the addition of a 10.5" gable band (size to match existing gable rake dimensions). This is to be located on both gables at the point where there is a "bumpout" in the gable between the 2nd and 3rd floor. This is intended to be James Hardie Fiber Cement in "Arctic White" The second, is that on the current trim band there is a cutout that can not be replicated using James Hardie Fiber Cement. This will need to be removed from the trim detail due to the limitations of the material, and will create a straight "face" on the mid band board.

The existing "Soffit Corbels (4) and Entry door accent trims (2)" are to be removed and reinstalled after completion of the siding, as to maintain the exact same fabric, and decorative features of the home.

The 3 existing storm doors at 3 entry points "outside of screen porch" are to be replaced with Anderson 3000 series color match "white" storm doors with brushed nickel handle set.

The current gutters are to be removed and replaced with a 5'' "K" style gutter with $3'' \times 4''$ aluminum downspouts to mirror what is currently on the home.

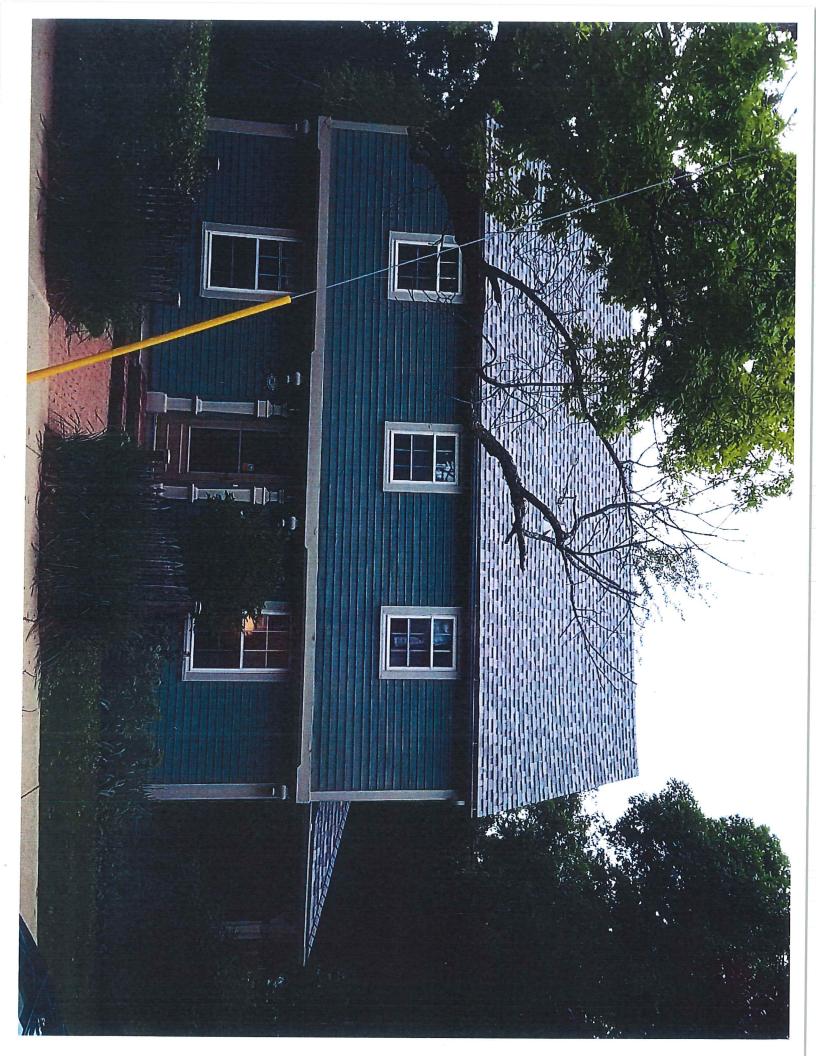
