I am writing to express my interest in appointment to the vacancy on the Madison Common Council created by the resignation of 16th District Alderperson Denise DeMarb.

My love affair with Madison began when I entered the University in the fall of 1968, one year before my future wife Susan began. When Susan and I left Madison in 1995 as the result of a career opportunity for her, we made ourselves two promises: that we would return to Madison when we were through elsewhere, and that we would stay away from Madison for no longer than five years. We broke the second promise, as five years grew to twenty, but we did not fail to keep the first, and we came home in 2015 to enjoy our retirement here.

I have always believed that public service, whether in elective office, as a government employee, or as a volunteer with service-focused not-for-profit organizations, is a most honorable calling and a privilege. I am particularly proud of the fourteen years I spent working in public health programming for the State of Wisconsin. As the enclosed CV indicates (see in particular "Memberships/Appointments/Volunteer Activities," Madison activities highlighted for ease of reference), I have served on the boards and committees of organizations at the local, county, state and international levels focused on such issues as literacy, hunger, governmental ethics, health care and public health.

In addition to the political experience one gains managing programs in an executive branch agency, not to mention working in an academic environment, I was twice, in 2012 and 2014, a candidate for an Illinois seat in the U.S. House of Representatives. While I succeeded both times in primary races, I lost to the incumbent in the general elections. It was, as my mother would always say, a learning experience.

Racial and income disparities in the city - disparities evidenced by statistics in arrest statistics, employment, poverty, homelessness, and health indicators - ought to be of paramount concern to all of us, and ought to be considered with every decision concerning allocation of community resources. We are all part of the community, whether rich, poor, young, old, black, white, hispanic or other, and we should all feel that the city sees us, hears us and cares about us. When

Madison is next selected as the most livable city in America, I would like to believe that the citation will point out that it is the best city for everyone. I am particularly interested in strengthening public education and public health; fostering economic development, particularly in areas of the city that currently lack strong economic bases; improving the city's transit system; and protection of Madison's unique - and beautiful - environment. Above all, I am interested in fostering good government.

As I mentioned earlier, I love Madison. I can assure both residents and Common Council members that I will work to the best of my abilities to serve the city well. I have no doubt that my I would seriously consider running for this aldermanic seat in spring 2019. Any final decision would be based on how effective a representative and advocate I feel I have been during the term of the appointment and, more importantly, how the residents of District 16 assess my performance.
