DRAFTER'S ANALYSIS: This is the annual City Attorney's Reviser's ordinance, correcting certain parts of the Madison General Ordinances (MGO), the City's code of ordinances.

The proposed changes in this ordinance are as follows:

1. Sec. 1.08(3)(a), MGO, is amended to correct an inaccurate reference.
2. Sec. 4.20(10), MGO, is amended to update an obsolete term and reference.
3. The title of Sec. 4.29, MGO, is amended to add "Policy on Receipt of Gifts" to the section title.
4. Sec. 7.07(8)(a), MGO, is amended to correct an obsolete reference.
5. Sec. 31.071(4), MGO, is amended to correct a typographical error.
6. The title of Sec. 33.13, MGO, is amended to add "Office and Chief of Staff" to the section title.
7. Sec. 45.07(7)(b)1.a.iii., MGO, is amended to correct a typographical error.

The Common Council of the City of Madison do hereby ordain as follows:

1. Subdivision (a) of Subsection (3) entitled "Schedule of Deposits" of Section 1.08 entitled "Issuance of Citations for Violations of Certain Ordinances and Providing a Schedule of Cash Deposits" of the Madison General Ordinances is amended to read as follows:

<u>"Offense</u>	<u>Ord. No./Adopted Statute No.</u>	<u>Deposit</u>
Public <u>in</u> decency.	26.01	\$500, 1 st
		\$1000, 2 nd w/in 5 yrs.
		\$2000, 3 rd w/in 5 yrs.

2. Subsection (10) entitled "Exclusions" of Section 4.20 entitled "Living Wage" of the Madison General Ordinances is amended to read as follows:

"(10) Exclusions. This section shall not apply to student learners, on-call employees, employees under the age of 18, or employees of sheltered workshops, as those terms are defined in Wis. Stat. ch. 104, ~~to City Special Workers Supported Employees~~ as defined in Section 3.54(4), MGO, or to laborers, ~~workers~~ or mechanics subject to ~~either Section 4.23, MGO, or to~~ 40 U.S.C. 276a 3142."

3. The title of Section 4.29 entitled "Affiliated Organizations for the City of Madison" of the Madison General Ordinances is amended to read as follows:

"4.29 AFFILIATED ORGANIZATIONS FOR THE CITY OF MADISON; POLICY ON RECEIPT OF GIFTS."

4. Subdivision (a) of Subsection (8) entitled "Food and Drink Permit" of Section 7.07 entitled "Regulations Regarding Foods Handled by Public Places" of the Madison General Ordinances is amended to read as follows:

"(a) No person, firm, or corporation shall sell at retail, offer for sale at retail, or hold for sale at retail any meat, fish, fruit, vegetables or other articles of food without possessing a food and drink permit in good standing. Such permit shall not be transferable from one location to another or from one person to another except as provided in Wis. Stat. § ~~254.64~~ 97.605. The permit shall be posted in a conspicuous place in the premises named in the permit. Only a person who complies with the requirements of this ordinance shall be entitled to receive and/or retain a permit."

5. The introductory paragraph of Subsection (4) entitled "Detached Canopy Signs" of Section 31.071 entitled "Canopy Signs" of the Madison General Ordinances is amended to read as follows:

“(4) Detached Canopy Signs. In lieu of a wall sign on the principal building, a sign that does not fit into any of the categories above may be displayed on a detached canopy if the canopy does ~~not~~ have a signable fascia, and, if the sign meets the following criteria:”

6. The title of Section 33.13 entitled “Common Council Executive Committee” of the Madison General Ordinances is amended to read as follows:

“33.13 COMMON COUNCIL EXECUTIVE COMMITTEE, OFFICE AND CHIEF OF STAFF.”

7. Subsubparagraph iii. of Subparagraph a. of Paragraph 1. Of Subdivision (b) entitled ‘Definitions’ of Subsection (7) entitled “Possession Of Assault Weapons Prohibited” of Section 45.07 entitled “Seventy-Seven Square Miles Ordinance” is amended to read as follows:

“iii. Baretta AR-70.”

EDITOR’S NOTE: The above term currently includes a hyphen. The correct terminology does not include a hyphen and should read as follows: “Baretta AR70.”
