Dear Heather,

Please include this letter and the attached petition in the Planning Commission materials regarding the 100 Block Ascendant/Provenance Hotel Project, and let us know if you have any concerns about this.

We served as members of the neighborhood steering committee to review the Ascendant Holdings/Provenance Hotel proposal, and were among the 8 of the 12 members who supported this project as currently being considered, including the zoning height variance for the elevation on the corner of Dayton and Carroll Street. Our perspectives, shared by the other supporting members, were summarized in our statement within the steering committee report.

What was not included in the report, due to minority objections, were the numbers of members supporting and opposing the project, or the supportive statements of many other residents during several neighborhood meetings.
