The City of Madison is planning a 2019 construction project Shepard Terrace, Chamberlain Avenue, Van Hise Avenue and Mason Street. The proposed project will include street improvements including connecting partial areas of existing sidewalk together and replacement of sanitary sewer main and laterals. Enclosed with this letter is a fact sheet with some details on the proposed project, which includes a map of the proposed project limits. Also enclosed is a notification for the Public Hearing before the Board of Public Works. The date, time and location of the public hearing is on the notification.

This project will involve special assessments to the owners of property adjacent to the project. The property owners will be assessed for various items included with this proposed project, and the costs of some of those items are assessed entirely to the owner. A table detailing the City's standard assessment policy for the items of work is included on the fact sheet.

Also enclosed is a Schedule of Assessments, which shows the estimated costs for each property adjacent to the project. After the work is complete, a final assessment will be calculated based on bid prices and work actually performed. The final assessment, which will be billed after the completion of the project, is payable in one lump sum or over a period of 8 years, with 3% interest charged on the unpaid balance.

# Fact and Details Sheet Proposed Shepard Tr, Chamberlain Ave, Van Hise Ave & Mason St Resurfacing with Utilities

#### Project Details - Proposed Work

Sanitary Sewer: The City will replace the existing sewer main with 8" PVC pipe (existing 8" clay main installed in the 1940s), and in most cases replace laterals from the main to the property line. In limited cases where the existing lateral is cast iron, appears to be in good condition upon inspection, and runs under a tree, the lateral will only be replaced to the back of curb. In those cases, the owner will not be assessed for the additional footage of replacement that is not completed. If you would like a full lateral replacement to the property line in cases such as this, please contact the Sanitary Sewer Contact listed at right (laterals assessable).

Water Main: Replace undersized main on around the Shepard Tr cul-de-sac and resolve some valve/hydrant problems in the neighborhood.

**Storm Sewer:** Add inlets to the intersection of Shepard Tr and Chamberlain Ave and along Shepard Tr near the Hoyt Park staircase Remove and replace inlets as necessary on the west side of Chamberlain Ave, Van Hise Ave and Mason St intersections with N Franklin Ave. If you are aware of any existing private storm sewer or private connections that discharge to the curb or to a structure from your property, please contact the Storm Sewer contact listed at right (*private connections assessable*).

Street: Replace asphalt, stone base, curb and gutter and driveway aprons on all streets (curb & gutter and driveway aprons assessable). The street width will remain similar as it is now 30-feet from face of curb to face of curb. Driveway aprons constructed with the project will match your existing driveway material. Driveway widths will be replaced per the City of Madison standard detail and driveway request forms will be provided in future mailings. Disturbed areas will be restored with 6-inches of topsoil and grass seed, which will be watered as needed by the contractor for the first 10 days.

**Sidewalk:** Existing sidewalk along Shepard Tr will be replaced. Connect sidewalk from the Hoyt Park staircase to Kendall Ave along west side of Shepard Tr. As well as from the Hoyt Park staircase along the west side of Shepard Tr to new sidewalk along south side of Mason St. Connect sidewalk from the Shepard Tr/Mason St intersection to the existing mid-block portion along south side of Mason St. As well as from the Shepard Tr/Van Hise Ave intersection to the existing mid-block portion and from the existing mid-block portion to N Franklin Ave along south side of Van Hise Ave (sidewalk assessable). Property owners receiving new sidewalk are eligible for the Safe Route Grant which covers 50% of the cost, this reduction is not reflected in the attached assessment.

Street Lights: There are no proposed changes to the street lighting.

Trees: Terrace trees may be pruned prior to construction to provide required clearance for construction equipment. Efforts have been made in the street design to save as many of the existing trees as possible. There are eight (122 Shepard Tr (Cottonwood), 217 Shepard Tr (Turkish Filbert), 2819 Chamberlain Ave (Norway Maple), 2814 Chamberlain Ave (Hickory), 214 N Franklin Ave (Silver Maple), 2821 Van Hise Ave (Norway Maple), 25 Shepard Tr (Silver Maple) and 2819 Mason St (Norway Maple)) planned tree removals with this project because of poor health/condition. There are two (202 Shepard Tr (Crabapple), 126 N Franklin Ave (Arbor Vitae)) planned tree removals with this project because of new sidewalk installation. If, during the course of construction, it is determined that any additional trees must be removed, adjacent property owners will be notified, prior to removal of the tree. The trees within the project limits that remain may have the roots trimmed during construction. Terrace areas will be evaluated by Forestry for new trees or replacements following the project.

#### **Construction Schedule & Impacts**

Tentative Schedule: April 2019 – July 2019.


Water Main: An average of two water shut-offs are expected for each property within the project limits. A minimum of 48 hours of notice will be provided prior to the shut-offs. Each shut-off may last up to 8 hours, but typically lasts about 4 hours.

Traffic Impacts: Shepard Tr, Chamberlain Ave, Van Hise Ave and Mason St will be closed to thru traffic within the construction limits. Local access will be provided, but driveways may not be accessible at times when work is being performed in front of the driveway and while new curb and gutter and driveway aprons are constructed. Driveway closures may last up to a cumulative total of 20 days. No parking is allowed within the construction zone during working hours (7AM to 7PM), so when your driveway is not accessible, you will need to park on the adjacent street (i.e. N Franklin Ave).

**Refuse Collection:** It will be the contractor's responsibility to allow for refuse collection to continue during construction. Please mark your address on your cart to make sure it is returned if moved.

Landscaping: Existing timber, brick or stone walls and landscaping plantings along the street or within the right-of-way will likely be impacted if it conflicts with curb & gutter, sidewalk or sanitary sewer installation. If you wish to save any landscaping, it should be removed prior to the start of work in the spring of 2019. Stone or brick pavers within the right-of-way on or adjacent to your driveway that you wish to save should be removed prior to construction and reinstalled by you after construction is complete.
