- Alder Verveer has sponsored an operating budget amendment to increase the Street Vending Monitor position from part time to full time in the 2019 Operating Budget.
- Staff from multiple departments have meet a number of times to discuss the best path forward for implementing the late fee system to vending licenses application process. There have been three options discussed for how to proceed for this next vending season and going forward.
  - 1. Add proposed late fee structure to Accela. Staff will track and manually enter in any late fees, issue invoices and follow-up on processing the applications, including the late fees due.
  - 2. Add late fee, process manually for 2019-2020 season while working on updating the application and website.
  - 3. Status quo for this vending season to give staff time to create a user friendly, more automated and complete application process including a new web landing page. This will also allow more opportunity for education of vendors.
