The footprint of Edgewood track hosting competition has had on the neighborhood surrounding the campus has been light. One conference meet per season is the norm with the grade school developmental track meet the additional endeavor. The latter is a late morning/afternoon hosting and has no need for dusk or dark lighting.

Badger Conference dual track meets can bring as many as 3 visiting teams to the campus although 2 additional is the usual. Including the host school, either 4 schools or 3 competing together during a scheduled visit occurs during a typical season. Because we are required to host a conference meet during the Spring track and field season, in the most recent past (prior to 2017) Edgewood has had to absorb the cost of renting tracks within the city of Madison, Middleton or Monona to accomplish the goal of fulfilling the conference obligation. (In 2016 Edgewood had to move its conference meet to Stoughton bringing the faculty, families and contracted officials to the available venue to run the meet.). But conflicts arise with those requests to outlying administrators because of the variety of spring sports scheduled for competition within the confines of the schools themselves. That was the case in 2016 when we hosted at Stoughton. The burden that placed on our available faculty, family and contracted officials and fan support suffered within that construct.

When the Goodman Athletic Field and track was completed for the 2016 season, Edgewood hosted a quad dual meet (4 schools). We had a 3:00 pm start because of a lack of field lights requiring schools in Monroe, Stoughton and Milton to leave their respective buildings with competitors, managers, coaches and staff missing the entire afternoon classroom schedule. Edgewood students had not completed their school day and the parking lot was full so that the 6 buses (one for each gender) that arrived had to maneuver to allow the visitors to depart. The buses then had to find parking as far afield from the Edgewood campus as beyond the zoo and Vilas Park because Edgewood had not dismissed classes.

The extra cost constructs and the need to drive Edgewood athletes leaving the campus for competitions brings another conversation into the discussion. It's well worth noting that being able to remain within the campus when assigned for a home competition plays well for safety and practicality. That and the fact that with Central Standard Time changing to DLST during our season means that a 4:30 start would have lighting turned on for such a short period of time that the neighboring confines would have little impact.

There has been some reflection regarding the West and East high schools having to use alternative competition sites. West high school, unlike Edgewood, never had the available property to build a suitable use facility. I coached at East high and discussion there about the building of a multi-use outdoor football, soccer and track had been "kicked about" for several years. It was brought up to me by people having knowledge that perk tests revealed the former landfill that makes up the field that exists would not support such improvements. The two public high schools in question, regarding their situation, reveals that even if the

climate in the respective school administrations wanted to build facilities within the confines of the schools existing property, they could not. Edgewood is not in that circumstance. The gift of the Goodman Foundation allows Edgewood to expand its reality. That should be allowed to happen.

I'm writing to ask you to give strong consideration to the Edgewood HS football field use. It seems that there is quite a bit of immediate neighborhood opposition, but I truly believe that much of it is related to the idea of **change**

. I found this story from 2012 and ask that you read it. This same neighborhood group was vehemently opposed to lighting the bike path. In fact, this neighborhood association very often is in opposition to any change at all. Change is hard. But they live in a city filled with change. In general-those changes improve our city. The Edgewood field improvements give an opportunity not ONLY for Edgewood students, but for the larger community. Many of the proposed events are coop events that bring together several differing high school students West and Edgewood coop on things like lacrosse. Monroe Street businesses will improve with new faces coming in for a bite to eat or a quick errand. Parking will be plentiful with the expanded Edgewood parking lot. And importantly-the Edgewood students will be able to enjoy practices on site rather than driving off campus during busy times of day increasing rush hour traffic.

So many of the concerns that the neighborhood has voiced have been answered. I know that Edgewood has worked not only to meet the city expectations of this project, but to **BEAT** those expectations. Edgewood strives to be a strong part of the community-both immediate community and larger community. It seems to me that this is an opportunity to give back to a campus that has given so much to Madison. The events are very limited appx 42 per year. They will not take place late at night nearly everything will end by 9pm. Lighting is laser focused to the field with little spill. Noise levels-well, I live across from Van Hise-Hamilton where I hear soccer matches often. I cannot say that this is anything but joyful. And, on the days I might want to take a nap while a match is going on, I simply close my windows.

I strongly encourage you to support Edgewood and the rest of the Madison community in this endeavor. Would you review the article included here? In hindsight-the bike path has been an incredible asset for Madison. I'm not a big biker, but I head down to campus on the bike path often and return at night. The opposition to the lighting of the bike path sounds very, very familiar to the opposition to Edgewood's project.

Change is hard for everyone. I assure you as a former parent of EHS students, Edgewood will do everything in their power to make this a positive impact on the community.

I write to express my strong support for Edgewood High School and their request to use their athletic field for several school sporting events annually. Thanks for taking the time to review my letter.

For the last several years, Edgewood High School and their representatives have worked hard to submit a thoughtful and balanced proposal for field utilization to the City of Madison Plan Commission. That work product is being reviewed by the commission now and will be considered for adoption on January 14th.

In short, my observations are Edgewood High School has been collegial and measured in their request. They have made numerous alterations to their field submission that recognizes the importance of being a "good community neighbor." They have adjusted and selected <u>state of the art</u> lighting fixtures that will illuminate the playing field, not the adjacent neighborhood. They have committed to using a low decibel, high quality public address system that strives to mitigate audible noise. From a traffic and parking perspective—Edgewood has taken advice from the Madison Traffic Department and will not allow side street entry to games, and has parking capacity to accommodate home and away guests. Finally, given Edgewood High School has an enrollment of 530 pupils, they have reduced seating capacity of the field to 1,000 guests. Currently, for afternoon games held on the field, attendance rarely exceeds 250 spectators.

I believe the student athletes of Edgewood High School have earned and deserve the right to play home games. The process has been considerate and balanced to date, but make no mistake about it; this is an issue of fairness and equity. The approval of the proposal by Edgewood High School to use the Goodman Field for athletic contests recognizes and pays homage to the generosity of the Goodman Foundation, who saw the community benefits this proposal allows.

With all of this as background, I urge you and your fellow colleagues to review the proposal and support its adoption. Sincerely,
