1. Project Description

a. What is the goal of your project? (500 characters)

UNIDOS seeks to expand its financial base and stabilize its management of existing grant and unrestricted fund development. Project goals include the research and development of potential foundation, grants & community-based organizations open to funding possibilities. The Bilingual/Bicultural Community Engagement Coordinator will organize and calendar all current grant management obligations and required documentation as well as continue to engage potential funders in UNIDOS service provision.

Dane County Latinx population is 4.1%Mexican, 3 % Puerto Rican, 1% Cuban; 1.3 other. We find the other category is Central and South American immigrants. UNIDOS serves new and long-term immigrant populations as well as US citizens of Latinx origin living in all areas and neighborhoods of Madison. Our clients range in age from children to the elderly with an average age of 18-55 years. They have 3-4 children. Spanish is their primary language. Their average hourly wage is \$8.

Bilingual/Bicultural Engagement coordinator. This newly improved position identifies sources of potential funding opportunities, engages with community members, partners and other spaces to provide information about the organization's functions and services, engages with potential volunteers by informing them of our volunteer opportunities, assisting in the building and maintaining of our network with other organizations and leaders of influence with the community, attending and tabling at activities/events in the city in order to build the organizations presence in the community. Project activities relevant to this application include becoming familiar with existing funding sources and requirements, researching and developing a list of potential application sources, developing organizational and project descriptions to include in outreach and application materials and organizing a calendar of actions to secure additional community unrestricted financial support. Volunteer training and support will be supported by DCF funds also in the project. City of Madison funds will be devoted exclusively to the development of expanding UNIDOS capacity to successfully manage, seek and secure funds to continue to develop and provide services.

d. Proposed Timeline for Implementation

 <u>Applicant Organization or Group</u>: (2500 characters) Briefly describe the structure of your organization. Include information about your board and/or volunteers. Please describe any successes you have had that relate to the proposed project. (10 Pts)

UNIDOS is run by the people it serves. The Board of Directors is a 10 member board. Currently, UNIDOS operates with a Board of Directors of 7 members and is actively seeking new board members. Six of our members identify as Latin@, one identifies as white. One member of the Board identifies as a survivor of intimate partner violence. Combined, the Board has 35 years of experience working with the Latinx

communities; working in a variety of capacities to include domestic violence, dating violence, stalking, sexual assault, housing, language access, equity and inclusion among many other areas. Members are recruited from the community of survivors, service providers and other individuals and professionals collaborating to advance safety and end violence in the Latinx community. Every effort is made to ensure this group is inclusive of all elements of the community including "minorities within the minority". The Board is directly involved in long-term planning, the development, and oversight of program and grant applications, fundraising and Executive Director performance evaluation. Also, it ensures that UNIDOS' actions are consistent with the Organization's mission and vision.

Successes: As this success continues it becomes imperative that we provide our ED with grant management and financial development support. In 2016 UNIDOS engaged in aggressive and successful financial development to meet the expanding demand for services. Positions were added, staff hired, at least 5 new funding sources were added. By 2018 our young and talented staff was stabilized and fully functional. The increased responsibility of the Executive Director has been huge. In 2017 UNIDOS launched a 24 /7 live responder Spanish language Helpline. 780 Spanish speaking callers received services from La Red. We are on track to serve 1000 callers in 2018. The supported referral process has proven to be well accepted and has allowed UNIDOS to build effective relationships with those programs to which callers were referred. As a result, more agencies are approaching UNIDOS to explore LA Red as a source of Spanish Language crisis intake services which have proven difficult for their agency to afford and provide on a regular basis. Our ED is continually meeting with support agencies and law enforcement to develop a memorandum of understanding to improve the referral process.

3. <u>Alignment</u>: (2500 characters) Briefly describe how your proposed project aligns with City, neighborhood or community based planning processes, data, or reports. (10 Pts)

UNIDOS became an active member of the City of Madison/Dane County organized group addressing the lack of access to the Spanish Language "live person" telephone crisis/information response in 2016. This group was made up of all service providers in the area who offer some form of Hotline Service. This was an essential piece of opening the door for UNIDOS to develop La Red. These conversations continued through most of 2016. The group estimated that operating a 24/7 Spanish language crisis line would cost about \$100,000. At this point, UNIDOS considers this a reasonable estimate of cost and has worked hard to secure funds at about that level. The variable in this formula is the ability to recruit and train a level of volunteer responders that can be supported by paid responders during times of volunteer unavailability. This requires continual effort at recruitment and training.

In addition, over the years UNIDOS has established great working relationships with community agencies and community members. La Red operation has only served to strengthen these relationships. Recently UNIDOS has developed MOU's with Fitchburg and Sun Prairie police. Regular contact is maintained with many organizations. UNIDOS also participates actively in many regular community groups, including the Catholic Multi-cultural Center, Commission of Sensitive Crimes- Coordinated Community Response Task Force, Communities of Faith to End Domestic Violence sub-committee, Latino Support Network, Latino Professional Association, Latino Children's and Families Council, Formando Lazos Familiares subcommittee, Supporting Families together Association, Latino Health Council, Dane County Coordinated Community Response to Sexual Exploitation of Children among many others. UNIDOS has a memorandum of understanding regarding referrals and service coordination with Domestic Abuse Intervention Services, YWCA and Vera Court Neighborhood Center/Alianza Latina and Rape Crisis Center.

4. Community Engagement: (2500 characters) Briefly describe how residents and the community who may benefit from this project have been involved in the development of this proposal. (10 Pts)

From the beginning, UNIDOS formed and maintained an advisory group to assist in the development of our existing and new programming. Composed of volunteers and members of Mujeres Adelante and Proyecto Dignidad (UNIDOS survivor based groups reaching out to the community to build skills and address issues of family violence and sexual assault in the Latinx community) they have and will continue to provide important input to the structure and operation of all of our programs. UNIDOS relies upon End Abuse Wisconsin,

Wisconsin Coalition Against Sexual Assault and Cases Esperanza, a nationally recognized, Minnesota Based Latin@ program technical assistance provider for support in this program expansion.

UNIDOS conducts an annual evaluation process with three main components. Staff and Board evaluations of service data and gaps identified in the process of providing service are compiled. The advisory groups are consulted in a meeting format where gaps, successes, and problems are identified and summarized. And finally, the collaborative partners are surveyed to determine the success rate of referrals and any issues that may need to be addressed in a review of the interagency agreements. This combination of listening and interacting has proven very successful in connecting UNIDOS to the community and developing innovative, creative programming to meet its ever-changing needs.

5. <u>Collaboration</u>: (2500 characters) Briefly describe any collaboration or coordination with other organizations or service providers in the development of this proposal. (5 Pts)

UNIDOS actively participates in all technical assistance provided by State and local funding sources. In this project, UNIDOS will seek additional support from United Way in carrying out this project. Community partner referral protocols are as follows:

Domestic Abuse Intervention Services of Dane County provides referrals for services for victims and survivors of domestic violence for on-going support and will assist with shelter services and legal advocacy as requested.

Multicultural Center provides referrals for services for victims/survivors and their children and will provide a private space to meet survivors if needed and support families with other basic needs such as food, clothing, employment, and immigration services.

Centro Hispano of Dane County provides referral services for adult victims/survivors of domestic abuse and children who have been impacted by domestic abuse and youth who have been victims of dating violence. Also, Centro Hispano provides UNIDOS meeting and/activity space for free and will assist with client employment and general support needs.

Supporting Families Together provides referrals for services for victims of domestic violence and will offer training to UNIDOS staff and support groups members, co-host two radio programs a year at La Movida Radio and co-facilitate parenting education and training for staff, volunteers and members of Mujeres Adelante.

Journey Mental Health Center provides referrals for services for children, youth and adult victims and survivors of domestic violence and sexual assault, assists with counseling services through the Latino Clinic and includes co-advocacy in the area of immigration remedies

Madison Metropolitan Schools provide referrals for children exposed to domestic violence and/or youth who have been exposed to or are experiencing dating violence.

Joining Forces for Families provides referrals for services for families impacted by domestic abuse and will assist with case management, housing, security deposits, and co-advocacy

Head Start provides referrals for services for children and families who have been impacted by domestic abuse.

Latino Children and Families Council and UNIDOS will co-facilitate four platicas per year related to the prevention of family violence and provides referrals for families impacted by domestic abuse and/or youth who have been affected by dating violence.

Department of Children and Families grants will support part of this position. Unrestricted fund development project will be dedicated to sustaining the project until the pressure of the current situation is successfully relieved. The WI Department of Justice has indicated an interest in assisting UNIDOS in further developing its long-term staff development by making funds available to increase wages and reduce work overloads. We are currently in conversation with DOJ staff to that end.
