# Ken Opin, Mike Rewey, Jim Oeth,

I am writing the three of you as members of the Plan Commission since you are the only members who I have actually met. Even though I currently serve on the Edgewood Liaison Team and have been the past president of the Vilas Neighbohood Association, the comments below are from me as an individual. I have served on the Edgewood/neighborhood Liaison committee off and on since it's inception. I have also worked on the Edgewood Master Planning team as a Vilas neighbor. During this time, the city has often held up the neighborhood/Edgewood interactions as the poster child for how sensitive development should happen. After the hard work of negotiation, neighborhood representatives have often spoken at Plan Commission meetings in support of various proposals. These success stories include: The central drive serving all three schools from Monroe St., Extra deep setbacks for dorm buildings, Agreement by Edgewood not to acquire single family residences in the neighborhood for student housing or office space, dark sky compliant light fixtures, storm water infiltration, sound mitigation of the air handling units on the Stream building, and underground parking in the Science building. The current auditorium addition and internal modifications to the high school received strong neighborhood support. All of these campus improvements took significant pushing from neighbors. I have not seen this type of negotiation success with the Stadium proposal.

I have been watching the Stadium improvement issue through both Master Planning processes where Lights and sound for the playing field were discussed but never put into the plan. At the Liaison meetings over the last year, the High School has carefully outlined their need for and enhanced stadium much in the same way it is outlined in their current application. I have participated in most of the discussions and the field trips to Waunakee to see LED lights in use. I have not seen support for the current proposal from neighbors at any of the Liaison meetings. After carefully listening to and considering the views of both Edgewood and the neighbors, I have reached the conclusion that the Lights, and amplified sound should not be installed. The negative impacts on neighborhood far outweigh the needs and advantages Edgewood High School has

outlined in the proposal.

Therefore, I urge you to reject the amendment to the Master Plan or any modification of the proposal that includes lights and amplified sound.

Dear Mr. Parks.

Unfortunately I will not be able to attend the meeting regarding the Edgewood Stadium Proposal as I have had a trip planned for over a year. I would however like to write in my opposition to the proposal of a Stadium/Sports Complex submitted by Edgewood College.

As a resident of Woodrow Street (living about 100 feet from the 10 yard line) I strongly oppose this proposal (as does more than 70% of the neighborhood). The DMNA neighborhood association has worked cooperatively with Edgewood in their desired building plans over the years. In almost all instances, with modifications they have done what they planned. Edgewood has floated a stadium proposal several other times in the 27 years I have lived in the neighborhood. The DMNA opposed this plan each time. It wasn't right for the neighborhood back then and it still isn't.

Edgewood students can continue to play sports as they do now. We are not against them playing sports. What we are trying to do is keep our neighborhood quality of life. While Alder Arnsten proposed "a compromise" by suggesting Edgewood go ahead and build the stadium with lights and amplified sound but only allow them to play 5 night games for the next 5 years (or until another amendment to the master plan comes along). Alder Arnsten's "compromise" simply provides facilities for much more extensive use in the future, at the cost of those of us living in the area who have invested hundreds of thousands of dollars in our homes. For most of us, this is our biggest life investment. We the neighbors, unlike Edgewood, are the ones who pay property taxes and support public institutions like the police & fire departments, public schools, etc. And we are the ones whose quality of life is most affected by this stadium proposal.

There are some time when one must simply stand up and say NO. There are times when no is appropriate. This is a time to say no. Edgewood is unable to mitigate the crowd noise. Already I can here the day time activities on the field even with my double paned windows closed. Edgewood is a commuter school in a neighborhood, not a neighborhood school. Please don't allow big money (Edgewood) to ruin the quality of our lives and our neighborhood. Please stand with us against the Edgewood Stadium proposal.

Dear Members of the City Plan Commission:

I write to register my strong opposition to the proposed Edgewood Stadium and to Interim Alder Allen Arntsen's "compromise" proposal. While I appreciate the desire for compromise, if this stadium is built, there is no guarantee that Edgewood won't soon be pushing for more games at night, and there will be no recourse if the surrounding neighborhood finds that the noise, the lights, or the traffic are problematic; the city has no ordinances for the noise and light pollution stadiums generate. Edgewood assured us a few years ago that they would not ask for a stadium. They did not remain true to their word. We have no reason therefore to trust that they won't be demanding more games soon.

As for the proposal itself, it serves the interest of Edgewood High School, but not the interest of the neighborhood or the city of Madison. Edgewood High School has fewer than 500 students, of which only slightly over a quarter live in the 53711 zip code (a zip code that extends into Fitchburg). Even fewer play football—a sport coming under increasing scrutiny because of the danger posed by concussions. The bottom line here is that Edgewood High School does not function as a neighborhood school.

Our neighborhood high school, West High, that genuinely serves this area has more than four times as many students enrolled (2,111 students) and yet they, like most urban high schools, manage without a local stadium. This is entirely appropriate, given the density of housing closely surrounding the school.

Edgewood is particularly close to its residential neighbors, so that a stadium will have significant impact. I myself live in the 2000 block of Jefferson, only 2 blocks from the campus, and I am distraught thinking of the noise that will disturb my gardening, my evenings in the back yard with friends or by myself. The noise, the traffic, the trash, the drunken people wandering into my yard from games at Camp Randall are plenty for me to deal with already; we don't need more noise and traffic and trash for the sake of a few very privileged high school students. I have lived in this historic neighborhood for thirty years, and it's a treasure for Madison: beautiful, serene, filled with birds because of its proximity to the UW Arboretum and Vilas Park. With the zoo on one side, and lively Monroe Street on the other, this desirable neighborhood is one of those that makes Madison an attractive city for people to move to and invest in. Its

serenity would be destroyed by this stadium and the quality of life here significantly diminished. My house is my nest egg, and I fear that property values will be negatively affected. (If so, the city would begin to lose tax revenue—this neighborhood has stunningly high taxes.) Let Edgewood use the money they have available to build a stadium do so in a significantly less densely settled place in the suburbs, combining forces with a suburban school.

Although it has been reported that the Vilas Neighborhood Association supports this development, I want it to be very clear to all involved in this decision that support for building a stadium is anything but unanimous in this neighborhood. I was unable to attend the Vilas Neighborhood Association meeting at which the vote was taken on the stadium, but my understanding is that even though the significant majority of those attending spoke against the stadium, those on the board who voted nonetheless did so unanimously in favor of the stadium. The board should represent their constituents, yet they failed to do so. (In consequence, a large number of residents showed up at the next meeting and voted out the president of the board, among others.) In the single block of Jefferson Street where I live, I know of at least ten residents of voting age who are opposed to having the stadium built. Please do not believe that the vote of the VNA board is a vote of the neighborhood, where there is in fact strong opposition.

Once a stadium like this is built, it can't be unbuilt and its impact can't be undone. Its construction is not in the interests of the residents of the neighborhood, of those who use Wingra Park or enjoy the recreational resources of Lake Wingra, or of the many city residents who regularly stroll along the Park and Pleasure Drive behind Edgewood. This is a very weighty decision. I urge you not to allow the interests of one small private high school to outweigh the interests of the residents of the neighborhood and of the city of Madison.

My family lives on Gregory Street, one block off Commonwealth. We used to live on Monroe Street, across from Woodrow St., and have lived in the neighborhood for over 22 years.

We support the proposed Goodman Athletic Complex for Edgewood High School and believe that Edgewood has acted responsibly in addressing potential parking issues as well as offering to buy the best sound and lighting equipment to keep disruption to a minimum for the neighbors.

While I understand the concerns of my neighbors, I think some of the reactions have been based on hyperbole and untruths which have led to irrational viewpoints. Here is a quote from a letter to the editor in yesterday's Capital Times: "The thought of nonstop amplified sound and crowd noise that will not be able to be moderated terrifies me."

"Non-stop"? For 25-40 events a year?

"Terrifies me"? Really?

There is an underlying, though seldom verbalized, sentiment that runs through the conversations on my neighbohood listserv. It is one of intolerence (from a supposedly progressive neighborhood) and anti-Edgewood bias. One neighbor wrote, regarding West High School not being included in the proposal that "very few Edgewood families live in our neighborhood so they can pay for what we have to put up with by giving us free use." So for some, it seems, noise and lights aren't the issue. They would gladly live with double the sound and lights if West were given free use of the field. Interesting.

Regarding the issue of the athletic complex causing environmental damage, it seems that a few games a year aren't going to cause any more damage than the overly amplified Jazz in the Park or the private 4th of July fireworks display in Wingra Park (both of which I enjoy very much from my house 4 blocks away.)

In short, it is not unreasonable to allow a high school to host high school activities, especially a high school that has been in the neighborhood for over 100 years, well before the neighbors purchased their homes.

Please act with reason and vote in favor of Edgewood's proposed Goodman Athletic Complex.

Anne Rosin, my wife, and I are opposed to the building of a new stadium at Edgewood College. We are also opposed to any proposed compromise that allows for building the stadium. Please vote against the construction of a new stadium.

Anne and I live in a single family, owner occupied home one and one-half blocks from Edgewood College at 2009 Madison Street. We will be directly impacted by the noise and additional congestion created by the stadium. We ask that the planning commission and city counsel oppose the stadium.

Our neighborhood is already impacted by congestion and noise from Camp Randell in the fall on multiple Saturdays. We can hear the crowd and music 5 blocks from Camp Randal on a Saturday afternoon. The local home owners and families should not be subject to additional loud noise and disruption caused by events at an Edgewood Stadium.

The proposed compromise that Edgewood be able to build the stadium with limited use during the current city master plan approved for Edgewood is also unaccepted. Seven years or any other limited duration with future possible changes is a very short period of time. Our house was built 119 years ago. Seven years or any other compromised time will go very quickly. The City needs to take a long term view for protecting the neighborhood. The stadium should not be built.

Unfortunately I will not be able to attend the meeting regarding the Edgewood Stadium Proposal as I have had a trip planned for over a year. I would however like to write in my opposition to the proposal of a Stadium/Sports Complex submitted by Edgewood College.

As a resident of Woodrow Street (living about 100 feet from the 10 yard line) I strongly oppose this proposal (as does more than 70% of the neighborhood). The DMNA neighborhood association has worked cooperatively with Edgewood in their desired building plans over the years. In almost all instances, with modifications they have done what they planned. Edgewood has floated a stadium proposal several other times in the 27 years I have lived in the neighborhood. The DMNA opposed this plan each time. It wasn't right for the neighborhood back then and it still isn't.

Edgewood students can continue to play sports as they do now. We are not against them playing sports. What we are trying to do is keep our neighborhood quality of life. While Alder Arnsten proposed "a compromise" by suggesting Edgewood go ahead and build the stadium with lights and amplified sound but only allow them to play 5 night games for the next 5 years (or until another amendment to the master plan comes along). Alder Arnsten's "compromise" simply provides facilities for much more extensive use in the future, at the cost of those of us living in the area who have invested hundreds of thousands of dollars in our homes. For most of us, this is our biggest life investment. We the neighbors, unlike Edgewood, are the ones who pay property taxes and support public institutions like the police & fire departments, public schools, etc. And we are the ones whose quality of life is most affected by this stadium proposal.

There are some time when one must simply stand up and say NO. There are times when no is appropriate. This is a time to say no. Edgewood is unable to mitigate the crowd noise. Already I can here the day time activities on the field even with my double paned windows closed. Edgewood is a commuter school in a neighborhood, not a neighborhood school. Please don't allow big money (Edgewood) to ruin the quality of our lives and our neighborhood. Please stand with us against the Edgewood Stadium proposal.

Dear Members of the Plan Commission,

I am writing as a Monroe St homeowner with property overlooking and within 100 ft of the Edgewood High School practice track and field. The purpose of my communication is to share with you the conditions residents have been experiencing from the practice field and to oppose any expansion of the facility due to the harm it causes to the livability of neighboring properties.

These are views from our home. Note that there is no buffer whatsoever between many homes and the field - contrary to Edgewood's claims of trees blocking light and sound.

Homeowners surrounding the proposed stadium do not oppose it because we fear what conditions might be like; we object to the stadium because we know what a stadium would mean, having already experienced disruption in our homes and properties during games and practices held on the field since the 2015 improvements.

As one example, this video linked below was filmed Oct. 25, 2018 at 5:23pm, with no zoom, from an open bedroom window as would typically be the case in spring, summer, and fall. Before filming, I took sound measurements using the National Institute of Occupational Safety and Health (NIOSH) Sound Level Meter app on my iPhone. While I understand this is not a professional study, the app has operated within +/- 2 dB of a calibrated sound meter, so readings provide a reasonable estimate of noise. Crowd noise was above 70 dB throughout the cheering with peaks above 80 dB *in our home* with the existing conditions. They were using amplified sound to announce players; however, the amplified sound is almost completely eclipsed by the crowd noise. I did not take sound measurements at the loudest parts, since I was filming. Please note the increase in sound at 0:31 when the goal is scored; this is what has been so disruptive about the games played on the field.

This event disrupted our family's evening. My husband was up at 3:30am in Afghanistan, where he is currently deployed, to 'join' us via video chat for a rare family dinner. By 5:15pm Madison-time, the noise in our home with the windows closed was so distracting that we gave up on having a family conversation. The increased frequency of game events on the Edgewood High School practice field have so negatively impacted the livability of our property, whether gardening, relaxing on our back porch, watching a movie, or sharing a meal, that we had considered moving and converting our much-loved home into a rental property even before the stadium proposal was formally submitted.

Technological fixes cannot mitigate crowd noise; allowing Edgewood High School to increase the capacity of the stands to 1000, with no daytime limits of use, and to expand their hours of field use by installing 80 ft high mount lighting would create a burden on the surrounding neighborhood and further harm our ability to enjoy our properties. Even practices, proposed until 7pm with lights any day, are audible in surrounding homes with repeated whistles and group cheering. The scoreboard has an amplified siren-type sound that is often used at short intervals during events, penetrating our living room and bedrooms.

While the athletic field is zoned for practices and physical education classes, many neighbors have been reporting ongoing problems caused by other, unapproved, uses to our alder, the DMNA liaison committee, City of Madison Police,

Edgewood, and by direct communication with users on the field. Issues have included excessive noise with events such as inter-school JV football, Varsity and JV soccer, and lacrosse games as well as track meets and amplified music at practices in addition to expanded hours of use from 6am to even after 10pm with individuals getting on to the field. Only recently did I learn that none of these complaints were shared with City zoning staff. Now that I understand we should have been reporting to a City of Madison zoning staff member, I will certainly do so going forward.

I appreciate your time reading my concerns as a property owner. The proposed stadium is simply incompatible with the proximity of residential property and would create an unreasonable burden and harm to neighbors. A stadium is not a necessity at this location, Edgewood has other options. I hope the city will reject the amendment to Edgewood's campus master plan and enforce current zoning agreements.

By now you have received multiple emails in multiple formats about Edgewood High School's (EHS) request to amend the Master Plan for a new stadium.

Please consider my letter to be one to support your decision to vote NO.

From my perspective, this boils down to the following questions:

1. What type of neighborhood does Madison want Monroe Street to be?

Monroe Street has been a darling of the city of Madison (Vote NO to keep it that way).

### 2. Is the city willing to reduce its tax base and provide more police services?

- YES to EHS means conversion of multiple single family homes into rental units and a decrease in value of neighboring properties.
- Increased police force to support parking/traffic/neighborhood disruptions.
   Theft, noise, and harassment have already increased as a result of field usage and activity associated with this process.

#### Additional considerations:

- I was raised in Madison, I went to EHS and have been a neighbor since 1991; I have supported Edgewood with past multiple compromises.
- I am appalled by the deceit of EHS and I do not feel that they should be rewarded again.
  - ➤ I understand there is a Goodman board member that is also on Edgewood's Board. A (disconnect) wonderfully generous Jewish community foundation gave money to a private Catholic High school for athletic events that does not support the city/community?
  - Although Vilas neighborhood association initially voted for EHS, the December meeting voted those Vilas/EHS board members out, Vilas now says NO.
  - ➤ EHS built this field outside of the Master plan with the intentions of creating a space they could rent out as a form of fund raising. They chose to give up the Edgefest we supported. EHS has proven itself to be a bad neighbor.

- ➤ Student populations are dropping, knowledge on sports concussions has increased, and fewer students are choosing to engage in football (EHS is not known for its sports). How can we support EHS when East and West have proven they can succeed without a stadium next door to their schools? This will not increase the student population.
- The proposal is a monstrosity that will impact the neighborhood quality.
  - ➤ 4 80' light poles (30 Candle), expanded seating (1200 fans), concessions, and an amplified sound system of min 60 db (actual sound study proves otherwise), with anticipated max of 40 evening games per year (this does not include day games/rentals).
  - ➤ EHS says the technology is available but this is false; noise/light cancellation technology does not exist.

Please note, in the spring of 2017, the Dudgeon-Monroe Neighborhood Association conducted a survey and found that 67.8% of the neighborhood residents who responded felt a stadium would be a detriment. Similarly, 2 of every 3 letters Alder Sara Eskrich received were in opposition. I encourage you to review the impact this will have on the city and vote NO on this proposal.

Other letters to you will cover the history of what has happened with the planning process. I ask that you take the time to consider their information.

The impact of a stadium in a beautiful residential district adds no value to the city of Madison, but will negatively impact it.

Please vote NO so you do not entangle yourselves in a highly questionable and deceitful process. I want what is right for Madison.

Dear Mr. Parks,

Let me begin by saying thank you for your service to the Madison community. As a native Madisonian, I am very grateful for the work that you and your colleagues do each day to make Madison such a wonderful place to call home. I have seen this city evolve and grow over the years and appreciate how we have managed to maintain the city's integrity while also ushering in development and expansion projects that have helped us embrace growth and change. In fact, one might say that it is by being open to growth and change, that we are honoring our city's rich history of forward-thinkers.

I am writing to ask you to support another expansion project, the Edgewood High School Stadium. I am an alumnus of Edgewood High School and Edgewood College. In addition, I have served for many years on the Dudgeon Monroe Neighborhood Association. I have always been as proud to be a part of the Edgewood family as I have been to be a member of the Monroe Street neighborhood. Unfortunately, that has recently changed due to the discriminatory and extremist attitudes that I have seen displayed by my neighbors towards my alma mater. I know that DMNA recently communicated a unanimous position against the stadium with the city, however this was quite an inaccurate portrayal of the neighborhood's voice. Unfortunately, the association is still desperately in need of voices from the Edgewood community (alumni and faculty/staff that live in the area) as well as apartment dwellers, who now make up a significant portion of our demographic in the neighborhood. Many members of the "old guard" of the neighborhood make it quite apparent to newcomers that neither have a place at the table, deterring fellow neighbors who might bring a more diverse background that better reflects the demographics of our neighborhood from participating in meetings and committees. I have been gravely disappointed in the words and actions of this subset of the association and felt compelled to share this disconnect between the association and the population it serves to help give you a better picture of how the neighborhood, as a whole, truly feels about this stadium. Despite what the very loud voices of opposition might want outsiders to think, there is actually quite a bit of support in the neighborhood of the stadium. The unfortunate truth of the matter is that years of dismissive and often discriminatory attitudes of a few neighbors have all but squelched the voices of those that support change.

In regards to reasons to support the stadium, I wanted to summarize just a few that I believe will have a positive impact on both Edgewood and the community. I ask you to consider them as you craft your final decision on the matter. Please consider the increased revenue that will return to Madison by allowing Edgewood to finally play home games in our city (on their home field) rather than having to trek into the likes of Middleton and Verona. Players, coaches, families, and other members of the crowd are currently spending their money on meals, fuel, etc. in other cities on Edgewood game days. This revenue can and should be circulating in Madison rather than in surrounding towns and cities.

Please also consider the positive impact that this will have on the students. When students feel at home on their school grounds, they inevitably have a more positive high school experience, which, statistically, leads to better community engagement in adulthood. The reverberating impact that this could have on our community is difficult to measure now, but easy to imagine. Doing what we can today to cultivate future engagement in the community tomorrow is a very wise investment and one from which we will all benefit.

And finally, please consider the precedent that this sets for the future. The neighborhood has been historically caustic to growth and change. My name is Jenny Sheahan and I am writing to you regarding the Goodman stadium issue at Edgewood High School. My husband and I have a son who has graduated from Edgewood, a senior currently at Edgewood and an 8<sup>th</sup> grader who will be attending Edgewood next year. We thought long and hard about our decision to send our kids to Edgewood as we both grew up in Madison and attended public schools all of our lives. For various reasons, attending Edgewood was the right choice for our kids.

Our sons have played sports at Edgewood all four years so we have attended various sporting events over those years that utilized the Goodman field. What an amazing field and a beautiful gift to the school. It is very much appreciated and used close to the fullest potential - - with the exception of hosting home varsity sports in the evening.

We feel it is a shame that the field is not used for Edgewood home varsity events held in the evening. It is a great field with so much more potential. By amending the master plan Edgewood would be able to share this gem with so many other schools that play our teams. And what a relief it would be for the Athletic Directors from these other schools for us to have the facilities to accommodate additional/rescheduled games at our discretion instead of at the mercy of other schools based on limited availability for their already over scheduled fields. These days finding a field that is available for sports, especially during bad weather spells, can be somewhat tricky and having an artificial turf field is such a great asset to the sporting community. Why not use the field to the best of its ability?

In addition, there are safety reasons for using this field for varsity games. The field is located at the high school so students could remain on sight for their home games. Currently students drive themselves, and classmates, to the in city limits fields which puts a lot of young drivers on the road. This can increase the risk of accidents or injury to the players and others, especially if weather conditions are poor. In addition, Edgewood has a large parking lot right on sight which keeps players, students and fans for both schools safe when parking. It is much more difficult for young high school students and even parents to feel safe parking alone on a dark side road at other stadiums that do not have parking lots available.

I understand that there are a few homeowners who have concerns with this change. Change is almost always uncomfortable for people but that does not mean it is always bad. For example, I am sure the area businesses would greatly appreciate the opportunity for increased business due to spectators choosing the Monroe Street area for dining or shopping, especially after the hardship they had to endure this past year with the construction on Monroe Street.

In addition, it is a school located in a neighborhood just like many other schools. This school that has been located there for many years and it has been a good neighbor in the neighborhood. A school brings with it so many positives for a neighborhood but of course there can be some inconveniences at time which the neighbors who choose to live there should expect. Edgewood has spent many hours and dollars planning a field that will have the least amount of negative impact as possible on the neighbors. This effort and consideration by Edgewood should be rewarded and not penalized.
