In anticipation of the forthcoming public hearing, I am writing to reinforce my strong opposition to Edgewood's proposal to build a stadium and associated infrastructure.

Edgewood High School, embedded in our community, adjacent to hundreds of homes, dozens of businesses, and one block away from Wingra Park, is not a compatible location for a stadium with amplified sound and lighting system. I live a few blocks away and our neighborhood will be significantly affected by the noise and lighting emanating from the proposed stadium.

When stadiums like this are built in new "green field" communities, they are part of an wholistic and specifically-designed community plan, which would include appropriate buffer distances and land zoning to accommodate the noise and light pollution from the stadium in relation to residences and businesses. Edgewood is in an established, century-old neighborhood with no possibility for light or sound buffer zones or other natural barriers to enable the stadium to coexist peacefully with residences.

The master plan that was put into place many decades ago carefully considered how to successfully integrate a high school and college campus within the residential Monroe Street neighborhood. This document and the community growth plans derived from it have benefitted both Edgewood and the surrounding community, resulting in improved quality of life for residents and those attending Edgewood College and High School. It has also resulted in continued positive financial growth as reflected by the wealth in increased property values and tax revenue that benefits the city.

Edgewood has proposed a fundamental change to the master plan to enable them to build a facility that is larger, louder, and more disruptive to the community than anything previously proposed. Nothing fundamental has changed in the neighborhood structure, community, or circumstances that warrant a change to a foundational document that has proven successful in guiding decades of community growth and change.

What has changed is that Edgewood College and High School has a strong desire and substantial private funding to build a structure and related systems that are fundamentally incompatible with the location and structure of the campus within a close residential community.

Students and families of Edgewood are the sole beneficiaries of this change and are the ones providing the funding for it. Those who attend Edgewood and benefit from the project are in large part not from the surrounding community but from Madison suburbs. Those who benefit from the stadium will not suffer its negative consequences.

Backed with substantial private funding, Edgewood has launched a publicity campaign attempting to diminish the perceived impact of the stadium, lighting, and sound on the community. The assertions made in their literature are highly misleading and are not backed by scientific fact. The stadium is immediately adjacent to neighborhood residents whose lives will be regularly and uninvitedly interrupted by the visual impact of 4.5 million lumens of light and sound levels exceeding 80 dBA inside their private homes.

The proposed stadium and related infrastructure are simply not compatible with the neighborhood and will have substantial negative impact on the quality of life of its residents, businesses, and parks and diminish residential property values.

I urge you all to oppose the Edgewood stadium proposal and any changes to the master plan.

Ms. Stouder:

We are writing to express our opposition to the proposed amendment to the Master Plan to allow Edgewood High School to construct a stadium with lights, amplified sound and expanded seating.

We have lived on Edgewood Ave (across from the Edgewood academic campus) for 14 years. We feel lucky to be part of a vibrant urban community. Although there are many drawbacks to living on Monroe Street (houses very close to each other, limited street parking, increased traffic, noise), we have always thought of these as part of the price for living here. In the time we have lived here, the density of the area has increased. A number of buildings have been torn down and replaced with mixed-use buildings each including several apartments. We have seen an increase in traffic and parking issues as a result. We are concerned that expanding Edgewood's stadium to host up to 40 events of up to 1000 spectators will add increased traffic in an area that is already congested. Although Edgewood has argued that they have ample parking for spectators and there will be no additional traffic, this defies simple logic. Currently, cars from the Edgewood campus routinely park in front of our house – this is before the increased spectators that would come from a new stadium.

Although we understand Alder Arntsen's effort in negotiating a compromise (only five evening football games and no increased daytime use), Edgewood has proved in the past that they are not honorable in keeping their promises. When the fields were originally upgraded, Edgewood was clear that the fields would only be used for practice and that they understood the neighborhood's opposition to lighting and sound amplification. Now, four years later they are asking to add lighting and sound. In fact, they currently aren't following the agreement they made in the Master Plan and are hosting games as well as renting it to outside customers. Although Edgewood has couched their request in terms of being able to have their football teams play on a home field, this is not completely honest. Hosting up to 40 events makes the stadium a revenue generating venue with little to no benefits to the neighborhood or city. No tax revenue will be generated, and a majority of students come from outside the city of Madison.

As residents of the Monroe Street neighborhood, we reap the benefits of living in an urban area. We also understand that living in densely populated area requires us to make accommodations so as to be good neighbors. Edgewood needs to understand this as well. The construction of this stadium is in clear violation to this.

- 1.) Edgewood claims that the stadium may create average sound in the area that that would measure in the 60 decibel range. Their statement to that effect is incredibly misleading. An "average" sound level is meaningless. If you were to stand at the Dane County Airport and measure sound for an hour you would find a similar "average" sound level in the 60 decibels range, but for that 45 seconds when a military fighter jet takes off from the runway the "peak" sound level would reach a disturbing 90 decibel range. It is that peak sound that affects humans, not an "average".
- 2.) The number of events described by Edgewood at the large Fall public neighborhood information meeting varied between 8 and 24 at different times, but I understand Edgewood is requesting an amendment allowing as many as 40 events. Clearly Edgewood gave the participants at the meeting false information. I purchased my home in 1982 on Keyes Avenue, a few blocks from The Edgewood campus. Part of the reason for choosing this house was that the neighborhood was quiet, with good public schools, and bordering Lake Wingra and Vilas Park.

I strongly oppose Edgewood's proposed amendment to their Master Plan. It is my understanding that our Interim Alderman Allen Arntsen (who does not live in the neighborhood) believes that noise is "part of living in a city." I disagree. There is a reason for Madison's noise regulations. Edgewood needs to recognize that the need for quiet is "part of being situated in a residential neighborhood." It appears that Alderman Arntsen prioritizes Edgewood's needs for bleachers, lights and sounds in their athletic program over the desires and needs of the neighborhood.

Alderman Arntsen states that "Edgewood's amendment sets forth technical information as to its proposed light and sound system that will limit the impact on neighbors and surrounding natural areas." However, the Concerned Engineers in the Edgewood's Neighborhood make a compelling case that Edgewood has misrepresented the impact that the proposed stadium will have on the neighborhood. The Concerned Engineers group have outlined facts on noise levels and lights based on actual measurements that contradict Edgewood's claims. Is this something that can be ignored and only rely on Edgewood's claims? I think not.

Edgewood's argument that their proposed athletic complex will serve as a community-wide asset for greater Madison. That is questionable. Only a fraction of the school's enrollment comes from the neighborhood and nearly half of the student population is from outside Madison city limits. Neither West nor East High Schools have attached stadiums, they have a City of Madison large student population, and the students are from the neighborhood. My daughter went to West. The lack of a stadium didn't affected her high school experience. Nor should it for Edgewood.

I understand that Edgewood has already violated the noise levels which has had a negative impact on the neighborhood. My understanding is that on November 20, 2018 the city's building inspection division issued a letter informing Edgewood that they would be receiving a formal notice of violation for this non-conforming activity unless their master plan was amended. There is a lack of trust in Edgewood.

In a 2015 Wisconsin State Journal article, Edgewood High School President Mike Elliot was quoted as saying that the neighborhood has been "vehemently opposed to us having lights or playing games here" and that what was being built then was for outdoor practices. That was the intent of the Master Plan and it should remain as a practice only field with no lights or a sound system.

I live about two blocks from the Edgewood practice field, across Monroe Street, and have lived here for 45 years. Most of my neighbors feel as I do —we really don't care if Edgewood High School adds improvements to their practice field to allow them to play football games at home. The impact on the neighborhood will hardly be noticeable. The five night games may produce a little crowd noise when a touchdown is scored, and maybe we'll hear the announcer once in awhile, but at night in the fall when windows are closed it won't be much. Walking down Woodrow Street yesterday I noticed that many of the No New Stadium signs that had been on lawns previously had been removed. There are signs on Monroe Street, but driving through the rest of the neighborhood there are very few. I don't know why the neighborhood association has taken such a strong stand. They cite a survey but it was taken in spring of 2017, with about 10% of the Dudgeon-Monroe households responding, and 2/3 of them against the project, which comes to about 100 households out of 1100—hardly representative. I am writing to urge you to vote No on the Edgewood High School proposal to expand their stadium.

A newcomer to Madison in 1995, I have lived on Woodrow Street for 20+ years now. I looked at 75 houses and ven though back in 1197 this one was about 10K over what we wanted to spend, all it look was a walk to the lake and I was sold. I've walked there almost every day since then and seen owls, and cranes and herons and I know I am lucky to live here. Up until now, I have watched as my neighbors worked with the Edgewood campus to make sure the 16 building projects were achieved with minimal disturbance to the community and I applaud their efforts. I could not let them do all of the heavy lifting on this though.

Edgewood High School made an agreement they never intended to keep. I take issue with the pretense that this stadium is for the community. I've yet to see an reasonable argument FOR the stadium except that they have the money. Edgewood is in the neighborhood, it's not a neighborhood school. Nearly 75% of the students don't even live in this zip code (which extends to Fitchburg). So, students and fans have to drive to games no matter where the stadium is. We live in a city with zoning laws. Allowing amplified light and sound sends the message that if you have enough money, the city will change the laws for you. The implications reach farther than the Dudgeon-Monroe neighborhood. To imply in any way that this benefits the Dudgeon-Monroe community is absurd. Mike Elliot wants to make his mark. The Stadium will be used a recruitment tool, a showplace for donors and a potential revenue generator. The only community the stadium will benefit is the Edgewood High School community. Frankly, I haven't even heard the college or elementary schools chime in with support.

Edgewood charges over \$11,000 per student. They are not required to accept all students. Its campus is private property. It is privately run, privately endowed and that is their first priority. I'm not being critical. It is a fact. Endowment and tuition funds have to be their first priority in order to exist. Edgewood is a lovely campus in an urban area and should have to abide by the same laws as its business and residential neighbors. I do not begrudge anyone their sporting events. They are part of the fabric of our culture. These sparsely attended events do not boost the Monroe Street economy. Whether they devalue the homes adjacent to the stadium remains to be seen. But what is certain is that they ONLY benefit a private institution.

The stadium was part of a 10-year "master plan" that WAS approved by the neighborhood, the City of Madison and more importantly, Edgewood High School! Edgewood agreed to a practice field with these restrictions. That's why they need an amendment to change it. They built it. Now they have changed their minds. High school president Michael Elliot is quoted as saying "We're not planning to do any concerts. We're not planning to rent it out." If Elliot changes his mind again, are the neighbors NIMBY objecting? Really? Why should we believe or trust him?

In my 20 years of experience, the Edgewood <u>college</u> campus has been a great neighbor. Negotiating with the neighborhood and taking environmental impacts (including flooding and light pollution) into account brought their master plan to fruition. Neighbors can use the college library and enjoy the exhibits and lectures there. Edegwood college has at least one live music event. It' sloud. But it's just one time a year. Maybe the high school should take its lead from the college and note that the community has been a good neighbor to Edgewood High School too. Several families right here on Woodrow Street send their children to Edgewood schools.

Nevermind that I have to walk past the insulting, bullying 8-foot high letters spelling out "Crusaders" every day. A team name celebrating the mass murder of Muslims and Jews. This isn't about that.

Nevermind that stadium supporters have vandalized and stolen our signs. This isn't about that.

Nevermind that Edgewood pays 0\$ in property taxes. This isn't about that.

Nevermind that Edgewood has a powerful donor base and a PR firm. This isn't about that.

This is about money, plain and simple. There is no way to enforce the compromise Alder Arnsten proposes. EHS has exceeded the agreed-upon use and sound levels already. There are a potential of 40 night events. Who can neighbors call if Elliot rents the stadium out for a marching band rehearsal? What will happen if they violate the agreement?

I do not know how far-reaching the implications of this amendment means to the rest of the city of Madison. But that is something to consider as well. We are just one neighborhood but approval of the stadium seems to imply that any developer with enough money can purchase the zoning laws. Imagine trying to get your child to sleep, reading a bedtime story, having a dinner table or telephone conversation in the middle of a football game. Because that is what it will be like for some of us close to the field. It will be as if we are on the field. I already have new windows for my bedroom and I can tell you that I heard the JV game announced with my windows closed this October.

Edgewood claims that they "deserve" this stadium because they have been good neighbors. In what universe is the reward for being a good neighbor, being a bad neighbor? What kind of neighbor wants to fill the streets with noise and light pollution for a potential 40 nights a year? Not a "good" one. Whether or not we prevail, I am filled with gratitude for my neighbors opposing the stadium. I still feel lucky to live here. Please vote no.

As a resident of Woodrow Street (living about 100 feet from the 10 yard line) I strongly oppose this proposal (as does more than 70% of the neighborhood). The DMNA neighborhood association has worked cooperatively with Edgewood in their desired building plans over the years. In almost all instances, with modifications they have done what they planned. Edgewood has floated a stadium proposal several other times in the 27 years I have lived in the neighborhood. The DMNA opposed this plan each time. It wasn't right for the neighborhood back then and it still isn't.

Edgewood students can continue to play sports as they do now. We are not against them playing sports. What we are trying to do is keep our neighborhood quality of life. While Alder Arnsten proposed "a compromise" by suggesting Edgewood go ahead and build the stadium with lights and amplified sound but only allow them to play 5 night games for the next 5 years (or until another amendment to the master plan comes along). The Friends of the Park & Pleasure Drive is a grassroots group comprised of nearly 30 people who live in the Dudgeon-Monroe, Vilas, Nakoma and Regent neighborhoods, as well as Fitchburg. We are opposed to the proposal by Edgewood High School for a stadium at their current track & field on the northwestern portion of their campus.

As the Chair, I have been asked why I am opposed to a stadium at this location. Madison is growing, and all of us need to accept more density, more noise, more lights. Dudgeon-Monroe is an urban neighborhood, after all.

But what about John Olin? From 1894-1909, Olin headed up the Park & Pleasure Drive Association which operated as the city's first unofficial Parks Department. Because of his vision, we have a multitude of parks for the public to enjoy throughout our city. John Olin's philosophy that all citizens should be able to partake of the benefits of nature shaped Madison's urban landscape, and has made ours the appealing city that it is.

If Olin had succumbed to the line of thinking that Madison was going to continually swell in population, and therefore we should relinquish our need for guiet places in nature, we wouldn't have all of these greenspaces we have now, over 100 years later.

And one of the special places that was created at that time is the Park & Pleasure Drive between the Edgewood campus and Lake Wingra connecting Woodrow Street to Vilas Park. It's a quarter-mile of a wooded roadside that got closed to through traffic in 2006, and has become a favorite place for recreational walkers, joggers, and bicyclists.

When you are back there, you can dare to believe you are not in the heart of a city anymore, but on some country lane miles away. If there is a northerly wind or no wind at all, you don't even hear the beltline - just the wind in the treetops, and birds, dozens and dozens of them that use this lakeshore haven for a resting spot on their migrations or for nesting. If you don't have a car to drive out to the countryside, you can bike, bus or walk here, and find some unexpected serenity.

This rustic road or linear park is about 2 blocks from the proposed stadium location. That's about 950 feet. The sound consultant that the No New Stadium group hired has said that the decibel level of a stadium crowd - with only 350 people and without pre-recorded sports music - will exceed 70 dB. Edgewood wants to host fans of almost 3x that many. The decibel level will rise substantially – especially with a sportscaster who needs to be heard over the roar of a crowd.

There is potential for this stadium to be in use both day and night for events eight months of the year - mid-March into November. That kind of activity this close to the Park & Pleasure Drive will be dramatically audible under the canopy of trees.

I urge you to support us in our efforts to protect the Park & Pleasure Drive from the noise and light intrusion of a stadium at such close proximity.

Please help us honor the legacy that John Olin left us.

Dear Editor:

In local and social media, we who oppose Edgewood High School's proposed stadium have been portrayed as stingy, over-privileged west-siders who should quit protesting and accept the stadium as a beneficial development. But no number of email lectures and political cartoons will negate the fact that adding a 1,000-seat stadium with lighting and amplified sound will change the nature of the neighborhood fundamentally for the worse. It's unlikely that many of our critics would accept that kind of change their neighborhoods.

Some have scorned stadium opponents for having a not-in-my-back-yard attitude, but that's easy to say that if the offending development is not in your back yard. We live a block away from Edgewood's practice field (where the stadium would be), which is essentially in our back yard. Those who live closer would have the stadium in their front yards. I'm not ashamed to say I don't want a stadium in my back yard, let alone in my front yard.

Edgewood has made much of its proposed technology for low-impact lighting and sound. Whether or not it would work as advertised, no technology will control crowd noise, which we already experience, often early on weekend mornings. Edgewood is using its practice field—which it promised would be used only for practices—for competitions attended by very loud crowds, and their seating now is a lot less than 1,000.

Edgewood claims there will be just 40 events per year in the new stadium. Remove the winter and mid-summer months from the calendar (24 to 28 weeks), and that amounts to an average of more than one event per week. Edgewood has shown it's not afraid to expand use of its facilities beyond what agreements allow for, and it will be tempted to grant requests for use by other institutions. Can Edgewood guarantee that we will not be seeing three or four events per week in the noisy stadium?

For these and other reasons, 75% or more of Edgewood's neighbors are opposed to the stadium plan. Edgewood should find a solution (another location) where a new stadium will not disrupt whole neighborhoods. The current stadium plan promises benefits for Edgewood's students and families—a transient community—but Edgewood's neighbors have invested greatly in the neighborhood for the long run. The benefits of the stadium for the Edgewood community don't outweigh the harm it will bring to the larger population of Edgewood's neighbors.

Anne and I live in a single family, owner occupied home one and one-half blocks from Edgewood College at 2009 Madison Street. We will be directly impacted by the noise and additional congestion created by the stadium. We ask that the planning commission and city counsel oppose the stadium.

Our neighborhood is already impacted by congestion and noise from Camp Randell in the fall on multiple Saturdays. We can hear the crowd and music 5 blocks from Camp Randal on a Saturday afternoon. The proposed compromise that Edgewood be able to build the stadium with limited use during the current city master plan approved for Edgewood is also unaccepted. While I am very pro sports and like the programs that all of our high schools have developed for our students to participate in, I feel that this stadium which has not been clearly defined and is possibly misrepresented in the descriptions of the impacts on the surrounding communities (sound, lighting, environmental impacts) should not to be approved just because Edgewood wants it. There are others impacted by this. The noise levels are very likely to be more intrusive than Edgewood predicts. Sound does not contain itself unless enclosed within a structure. To say otherwise is misleading and disingenuous.

Even the statement by the president that "Edgewood has been up front about the desire to have a true home field by ... hosting night games as required by the Badger Athletic Conference... Actually that conference only includes universities, not high schools.
