Being Lot 1 and 2, Certified Survey Map Number 4826, as recorded in Volume 14 of Certified Survey Maps, on page 41, as Document Number 1911411, Dane County Registry, located in the City of Madison, Dane County, Wisconsin, more fully described as follows:

Commencing at the South Quarter Corner of Section 19, Town 7 North, Range 10 East; thence N89°06'26"E along the south line of the Southeast 1/4 Quarter, 566.93 feet; thence N02°17'05"W, 33.02 feet to the north right of way of Frazier Avenue and being the southwest corner of said Lot 1, Certified Survey Map number 4826 and being the Point of Beginning; thence continuing N02°17'05"W, 149.98 feet to the northwest corner of said Lot 1; thence N89°05'33"E, 291.84 feet to the northeast corner said Lot 2, C.S.M. 4826 on the west right of way Fayette Avenue; thence S04°04'21"E, 128.94 along said west right of way to a curve to the right; thence along an arc of curve 32.54 feet with a radius of 20.00 feet whose cord bears S42°19'40"W, 29.07 feet; thence S89°05'25"W, 275.44 feet along the north right of way of said Frazier Avenue to the Point of Beginning.
