PURSUANT TO SECTION 38 OF THE MADISON GENERAL ORDINANCES AND CHAPTER 125 OF THE WISCONSIN STATE STATUTES.

Premise: Beer stored in the cooler and alcohol stored behind the counter.

Common Council granted license in 2007 with the following conditions:

- 1) No Sale of single bottles or single cans of beer or fermented malt beverages.
- 2) No sale of 40 ounce bottles of fermented malt beverages.
- No sale of fortified wines.
- 4) The establishment shall not sell, dispense or give away intoxicating liquor in the original container in amounts of two hundred (200) milliliters or less in volume. 'Intoxicating liquor' shall not include win in the original container with an alcohol content of 15% or less by volume. (Added by Common Council 6/6/2017)

Common Council granted renewal 6/7/16 with the following conditions:

The conditions are all existing conditions and:

- 5) Report any criminal activity within 12 hours of occurrence.
- 6) Post signs on the storefront that read, "No consumption of alcohol on property."
- 7) Pick up bottles and other trash on premises, including rear of premise, at least once per day.
- 8) Conduct hourly sweeps of the parking lot and report loitering and/or drinking in the lot to the Madison Police Department.
- 9) Rework the language on "No trespass" signs to address those who have completed their business at Madison Bazaar but remain on the lot.
