

PURSUANT TO SECTION 38 OF THE MADISON GENERAL ORDINANCES AND CHAPTER 125 OF THE WISCONSIN STATE STATUTES.

Premise: Beer stored in the cooler and alcohol stored behind the counter.

With the following conditions:

- 1) No Sale of single bottles or single cans of beer or fermented malt beverages.
- 2) No sale of 40 ounce bottles of fermented malt beverages.
- 3) No sale of fortified wines.

Common council granted on 6-6-2017 with the following condition:

- 4) The establishment shall not sell, dispense or give away intoxicating liquor in the original container in amounts of two hundred (200) milliliters or less in volume. 'Intoxicating liquor' shall not include wine in the original container with an alcohol content of 15% or less by volume.
