Concerns Regarding the Proposed Road Project in Sunset Memory Gardens Cemetery April 8, 2019

My name is Jude Morse. I've owned and lived in my Tamarack Trails home in Madison at 7381 Tree Lane immediately adjacent to the Sunset Memory Gardens Cemetery for 24 years. I am here today in support of the concerns identified by others about the proposed road project in the Cemetery and I would like to focus on three areas of concern:

1) The first concern I want to focus on is the Tamarack Trails Board has not provided an appropriate meeting for the impacted Tamarack Trails homeowners and others to discuss concerns, for the predicts is the taway of taway of the taway of taway of

In addition to these horrible weather problem that prevented many Tamarack Trails homeowners from participating in the January 28th meeting, the Tamarack Trails Board did not accurately inform homeowners about the importance of the January 28th meeting. Instead the Board stated in the notice to the homeowners adjacent to the Cemetery and also in the "Condo Newsletter": <u>Please keep in mind that this is very early in a continuing</u> <u>discussion between all entities involved."</u> (See copies I've submitted of the January 10, 2019 notice to "Tree Lane and Randolph Drive Residents" and "The Good Life… " newsletter.)

<u>Therefore the Tamarack Trails Board should be required to conduct another</u> <u>meeting for homeowners to adequately provide that essential part of this</u> <u>process</u>.

2) The second concern I want to focus on are problems with the design of the proposed road. In addition to other concerns expressed by my neighbors, the proposed road would not, as stated by the applicants, provide an opportunity for both parking near a grave and also for driving on the proposed road. Because the proposed road is approximately eight feet wide, there would not be enough room across the width of the proposed road to pass by another vehicle already parked while visiting a different grave along the proposed road. Because there would not be enough room across the width of the proposed road to pass by another vehicle already parked while visiting a different grave along the proposed road for both a vehicle parking near a grave and also another vehicle already parked on the proposed road, the driving-by vehicles will be forced to drive off the road and likely drive onto Tamarack Trails' property.

Therefore this proposed road project should not be approved.

3) <u>The third area of concern I want to focus on is the proposed road project will</u> <u>cause a serious increase in the Cemetery's drainage problems that already</u> <u>negatively severely impact on Tamarack Trails' homeowners and residents.</u> This afternoon at 1:00 I measured an area of accumulated standing water 64 feet by 9 feet of standing water at least 3 inches deep in the proposed road project's area. From my 24 years of living in Tamarack Trails immediately adjacent to the Cemetery, I know this is not unusual and has been worsening over time because the Cemetery is located on "marshy" land plus all the burials in the ground further disrupt the otherwise natural drainage into the Cemetery's ground.

And during the 24 years I've lived in my Tamarack Trails home immediately adjacent to the Cemetery, I've observed serious problems with mosquitos nesting in the accumulated standing water on the Cemetery. I've also

observed several ducks swimming around on accumulated water in the Cemetery!

In addition to the serious existing problems due to accumulated water on the Cemetery, there are severe drainage problems from the Cemetery into Tamarack Trails' property. When I moved into my Tamarack Trails home 24 years ago, there was a log retaining wall by my home along the edge of Tamarack Trails' property adjacent to the Cemetery. Frequently there was so much water gushing out of that log retaining wall that it looked like 20 water faucets had been turned on full-force within the log retaining wall! After several years of that severe gushing of water through the log retaining wall, the wall collapsed and was removed by Tamarack Trails. However frequently there still is such severe drainage from the Cemetery that it creates a sheet of ice along the cul-de-sac road from the Cemetery down to Tree Lane during the colder weather and creates a slippery wet area in the warmer weather. These icy and slippery areas are especially dangerous for a person like myself with multiple severe spine and neurological disabilities.

Therefore for this proposed road project, even if not automatically required by the City of Madison for this type of project, given the severe existing drainage problems in and out of the Cemetery, I urge you to require the type drainage system for the proposed road project that was required for the proposed mausoleum project in the Cemetery approximately 20 years ago.

Thank you for listening to my concerns and recommendations.

Rain gardens, stone riprap, swales and catch basins were discussed as several of the numerous suggested options.

Capri Senior Communities

From West Place Workgroup

With senior housing going in at both ends of Tree Lane, we know it's confusing. We're talking about the development that is being planned for the West Place Property adjacent to Tamarack at Honey Locust and Mountain Ash.

The project is being developed for Capri Senior Communities, based in Waukesha. They have an option to purchase the land, contingent on a change in zoning and City approval of the project. While the West Place Workgroup has conveyed some concerns to the developer, we have been pleased with their responsiveness.

The property will be accessed from Tree Lane across from the Wexford Apartments. City staff has requested a street to connect with the private Navitus Drive and, ultimately, to Mineral Point Road.

At the December 13th Neighborhood Meeting, a revised site plan was presented. The threeand four-story structure would have 171 one- and two-bedroom units (135 units of independent living and 36 of assisted and/or memory care) ranging in size from 700 to 1,200 square feet. Capri generally accepts privately-funded independent and assisted living residents.

In addition, there would be 17,000 sq. ft of common area which would include a coffee shop for residents, a café and a wellness center. Underground parking would accommodate 145 vehicles.

The next Neighborhood Meeting will be held in February. Construction would start in Fall 2019.
