Assistant City Attorney Jennifer Zilavy filed a complaint with the Madison City Clerk's Office seeking non-renewal of the above-captioned Class A Beer/Class A Liquor licenses. A non-renewal hearing was scheduled before the Alcohol License Review Committee ["ALRC"] on May 2, 2019 at 5:30 p.m. Attorney Charles Giesen, attorney for Respondents, contacted Attorney Zilavy the afternoon of May 2, 2019 for purposes of proposing a settlement. In lieu of conducting the non-renewal hearing, the parties agreed to the following:

1. Renewal of the Class A Beer/Class A Liquor licenses for North American Group of Companies, Inc., d/b/a Madison Bazaar, 1901 S. Park Street, Madison, Wisconsin, and

MACRO Inc., d/b/a West Badger Liquor, 714 W. Badger Road, Madison, Wisconsin.

2. Nadeem Syed was present and agreed to the final terms of this stipulation Syed is the liquor/beer agent for both Respondent establishments.

3. Respondents (Syed) agree to surrender each establishment's liquor license at close of business on November 15, 2019.

4. From May 3, 2019 through June 30, 2019, Respondent shall be allowed to sell intoxicating liquor in amounts of two hundred (200) milliliters ["ML"] or less in volume, excluding fifty (50) ML bottles, at Madison Bazaar, 1901 S. Park Street, Madison, WI, consistent with their previously amended liquor license conditions. Sales of fifty (50) ML bottles of intoxicating liquor are not permitted at any time.

5. Effective July 1, 2019, Respondent agrees that Madison Bazaar shall no longer be permitted to sell intoxicating liquor in amounts of two (200) ML or less in volume at 1901 S. Park Street.

6. Respondents agree to comply with all other conditions currently imposed on their liquor licenses for Madison Bazaar and West Badger Liquor.

7. Respondents agree that if they violate any condition on their liquor licenses between May 3, 2019 and November 15, 2019, both liquor licenses shall be subject to immediate revocation after a due process hearing before the ALRC if the ALRC finds the violation(s) sustained.


8. Respondents agree to dispose of all fifty (50) ML bottles of intoxicating liquor currently at Madison Bazaar and West Badger Liquor. Respondents shall provide proof of proper disposal in the form of official documentation from a distributor that the 50 ML bottles were returned to the distributor. If Respondents decide to destroy the fifty (50) ML bottles rather than

return them to the distributor, they shall do so in view of the Madison Police Department South Police District. If Respondents choose to destroy the fifty (50) ML inventory, they shall contact Madison Police Officer Joshua Bower of the South Police District to arrange supervision of said destruction.

The parties hereby agree to all terms and conditions stated in this Stipulation.


