Dear Alder Bidar,

Regarding our entertainment license application, I wanted to let you know that based on past years, we anticipate hosting events with a DJ for 10-15 private (such as weddings) events per year in our main, Ameche, ballroom. This holds about 200 people for a wedding. Sound will not exceed 60 decibels at the property line. I don't anticipate having live music such as bands; however we may rarely having something low key such as a solo player (in my six years at the Inn Towner, we had a violin player once for a hospital event). We certainly do not plan anything nightclub-like with live music and admittance at the door.

We have had no problems in the past. We value our good relationships with you, the Regent Neighborhood Association, and the police department. Our plans under this license should continue those good terms. I've attached our security plan.

It's my understanding you will now share this with the Captain and with RNA.

Please let me know our next steps, timeline, and if you have any questions.
