Brandi also runs a community lead and funded program called the Eviction Prevention Fund for Black families. This fund (spearheaded by herself) is to help prevent black families from eviction, helps prevent utilities to be disconnected, provides funds for security deposits and has helped homeless families by paying some lodging costs. She's an amazing orator on issues of racism and our personal roles in eradicating oppressive systems and thought.

Brandi's work in the late 90's has been organized on UW Madison's campus supporting the creation of the Multicultural Student Center. When Hurricane Katrina displaced Black families, Brandi supported and organized resources and found homes for families refuged here in Madison, WI. After Mike Brown was murdered in Ferguson, Missouri, Brandi organized Madison's first rally for Black Lives Matter and later helped found the Young, Gifted and Black Coalition, which used direct actions and community education forums & trainings to organize the Madison community around issues of mass incarceration, the new jail, poverty and police brutality. She volunteers her time tirelessly as a parent advocate and peer support specialist for Black families. As a full-time mother of a 25-year-old daughter; 19-year-old daughter and a 3-year-old son, she finds time to address these issues not to mention she's a treatment level foster mother who specializes in high behavioral and emotional trauma. Last but not least, she's a radio talk show host on Talk92.7FM--the Unheard Of Show with Brandi Grayson in which she addresses a variety of racial disparities. You can catch her every Tuesday & Wednesday at 6PM.

I cannot stress enough how this woman brings Black Girl Magic to Madison. All of these things that Brandi does is by her own volition and offer these services for FREE.
