Type of live entertainment to be offered: _ Live music will be allowed for private events. Non-amplified music or limited amplification only Number of security personnel and how they will be utilized: Security staff used, when necessary, to check IDs, control capacity and monitor patron activity Description of clothing to identify security personnel: _ Black t-shirt with "SECURITY" printed across the back Plan to handle control and clearance of the parking lot during hours of operation and at closing time: Parking lot (19 spaces) is monitored with video surveillance system and intermittently by staff throughout the day. Gates closed only for special events as some guests may leave vehicles parked overnight How will the entrance line be managed and controlled: _ We do not anticipate the need for a line as no such events are planned. Plan for unruly patrons, intoxicated patrons, and physical disturbances: Staff has been instructed to not physically engage with patrons and to use verbal instructions to direct unruly patrons out of the establishment if/when necessary. Physical disturbances to be reported to MPD when deemed appropriate. Underage drinking and fake ID plan: Underage persons are allowed within the restaurant space during regular hours. No one under the age of 21 permitted to consume alcohol on the premises. Any Fake IDs presented will be confiscated and turned over to MPD-Plan to control and supervise patrons under twenty-one (21) years of age: Patron's IDs to be checked by bartenders and servers upon request of an alcoholic beverage (premise operates as a full service restaurant). Underage persons are not permitted to be served alcohol and groups will be asked to leave if observed providing an alcoholic beverage to an underage person. No one under the age of 21 will be permitted entry after (Samba Brazilian Grill hours) or as approved by Management during a scheduled private event (typically for weddings, etc.) How will orderly appearance and operation of the premises be maintained in regard to litter and noise: Full staff is on hand every day to perform cleaning and general maintenance duties of the interior and exterior of the Limited amplification of live instruments, vocals or recorded music is allowed, with the intent of providing a level of noise sufficiently low so as to allow for conversation between patrons at all times.
