DRAFTER'S ANALYSIS: Section 23.61 is created to regulate goods and services advertised online that are required to be licensed. Internet marketplaces and social media sites are increasingly used to advertise goods and services that the City of Madison or a Wisconsin state agency regulates with a license; such as tattooing, food items or tourist rooming houses. The City of Madison has an interest in ensuring compliance with both local and state laws as well as preserving the health and safety of its citizens. Under *Central Hudson Gas & Electric Corp. v. Pub. Serv. Comm'n of N.Y.*, 447 U.S. 557 (1980), the government may ban advertising by businesses that are operating illegally, such as unlicensed business where a license is required if necessary to advance the government's interest. This ordinance will provide Public Health Madison Dane County and Building Inspection an enforcement tool.

The Common Council of the City of Madison do hereby ordain as follows:

1. Section 23.61 entitled "Internet Solicitation of Unlicensed Regulated Businesses" of the Madison General Ordinances is created to read as follows:

"23.61 INTERNET SOLICITATION OF UNLICENSED REGULATED BUSINESSES.

(1) In this section:

"Internet" refers to the public worldwide computer system, which allows people to access web pages or services, including, but not limited to, Airbnb, VRBO, Facebook, social media sites and other similar services.

"Regulated business" means a business and/or individual subject to a required license issued by Public Health Madison Dane County and includes but is not limited to tourist rooming houses, retail food establishments, tattooists, and body piercers.

"Solicit" includes, but is not limited to, those circumstances where a person uses the internet in a manner and under circumstances to advertise a good or service.

"Unlicensed" means not possessing a valid Lodging license, Food and Drink license or a Tattoo/Body Piercing Establishment license issued by Public Health Madison Dane County or a valid State of Wisconsin agency license.

- (2) No person shall use the Internet to solicit or advertise an active listing for an unlicensed regulated business.
- Any person violating this section shall be subject to a forfeiture of not less than twenty dollars (\$20) nor more than two hundred dollars (\$200). Second and subsequent violations shall be subject to a forfeiture of not less than fifty dollars (\$50) nor more than three hundred dollars (\$300)."
- 2. Subdivision (a) of Subsection (3) entitled "Schedule of Deposits" of Section 1.08 entitled "Issuance of Citations for Violations of Certain Ordinances and Providing a Schedule of Cash Deposits" of the Madison General Ordinances is amended by creating therein the following:
