

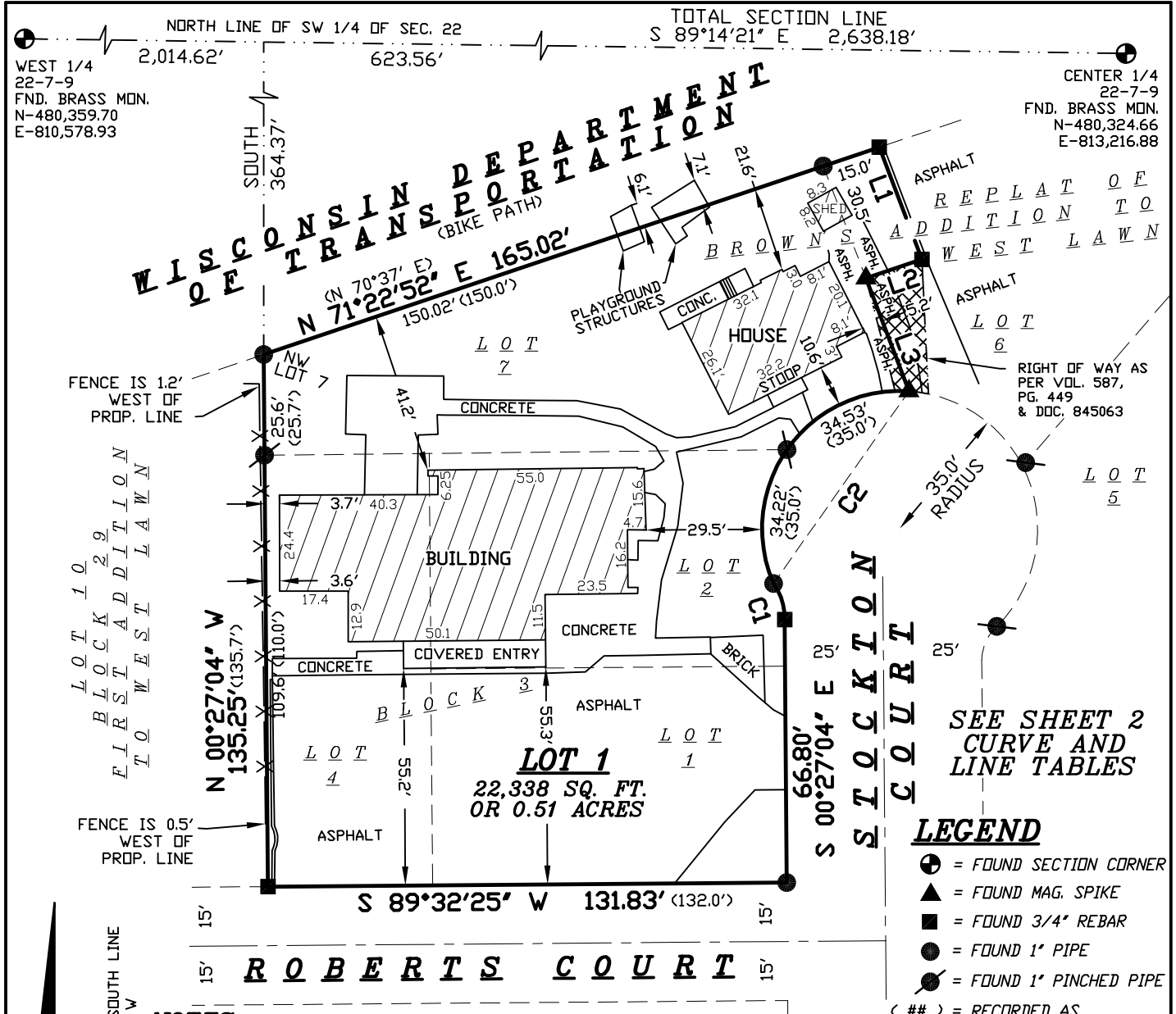

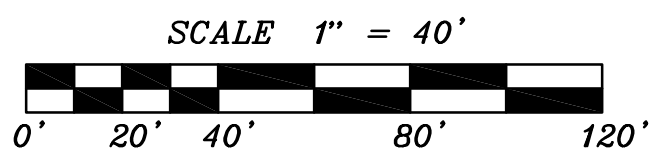

SURVEYOR'S CERTIFICATE

I, Noa T. Prieve, Registered Land Surveyor hereby certify that in full compliance with the provisions of Chapter 236.34 Wisconsin Statutes, the subdivision regulations of City of Madison, and by the direction of the owners listed below, I have surveyed and mapped a correct representation of all of the exterior boundaries of the land surveyed, being part of the NE 1/4 of the SW 1/4 of Section 22, T7N, R9E, City of Madison, Dane County, Wisconsin. Including all of Lots 1, 2, and 4 of Block 3, Brown's Addition to West Lawn, and also Lot 7 and a portion of Lot 6, Replat of Brown's Addition to West Lawn, more particularly described as follows:

Commencing at the West 1/4 corner of said Section 22, thence S 89°14'21" E along the north line of the SW 1/4 of Section 22; thence due South, 364.37 to the northwest corner of Lot 7 and also the point of beginning.

Thence N 71°22'52" E along the south line of a Wisconsin Department of Transportation bike path right of way, 165.02 feet; thence S 20°48'56" E, 30.50 feet; thence S 71°22'52" W, 15.00 feet; thence S 20°48'56" E, 30.70 feet to the right of way line of Stockton Court; thence along the westerly right of way line of Stockton Court for the next three courses, thence along an arc of a curve concaved southeasterly having a radius of 35.00 feet, a long chord bearing of S 35°06'32" W and a long chord distance of 59.79 feet; thence along an arc of a curve concaved southwesterly having a radius of 15.00 feet, a long chord bearing of S 17°11'09" E and a long chord distance of 9.60 feet; thence S 00°27'04" E, 66.80 feet to the north right of way line of Roberts Court; thence S 89°32'25" W along said north right of way line, 131.83 feet; thence N 00°27'04" W, 135.25 feet to the point of beginning. The above described parcel contains 22,338 square feet or 0.51 acres.

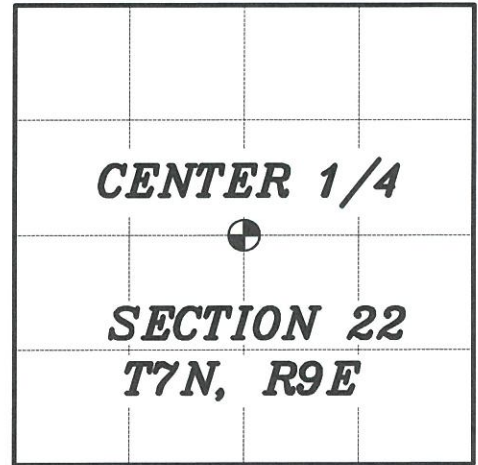

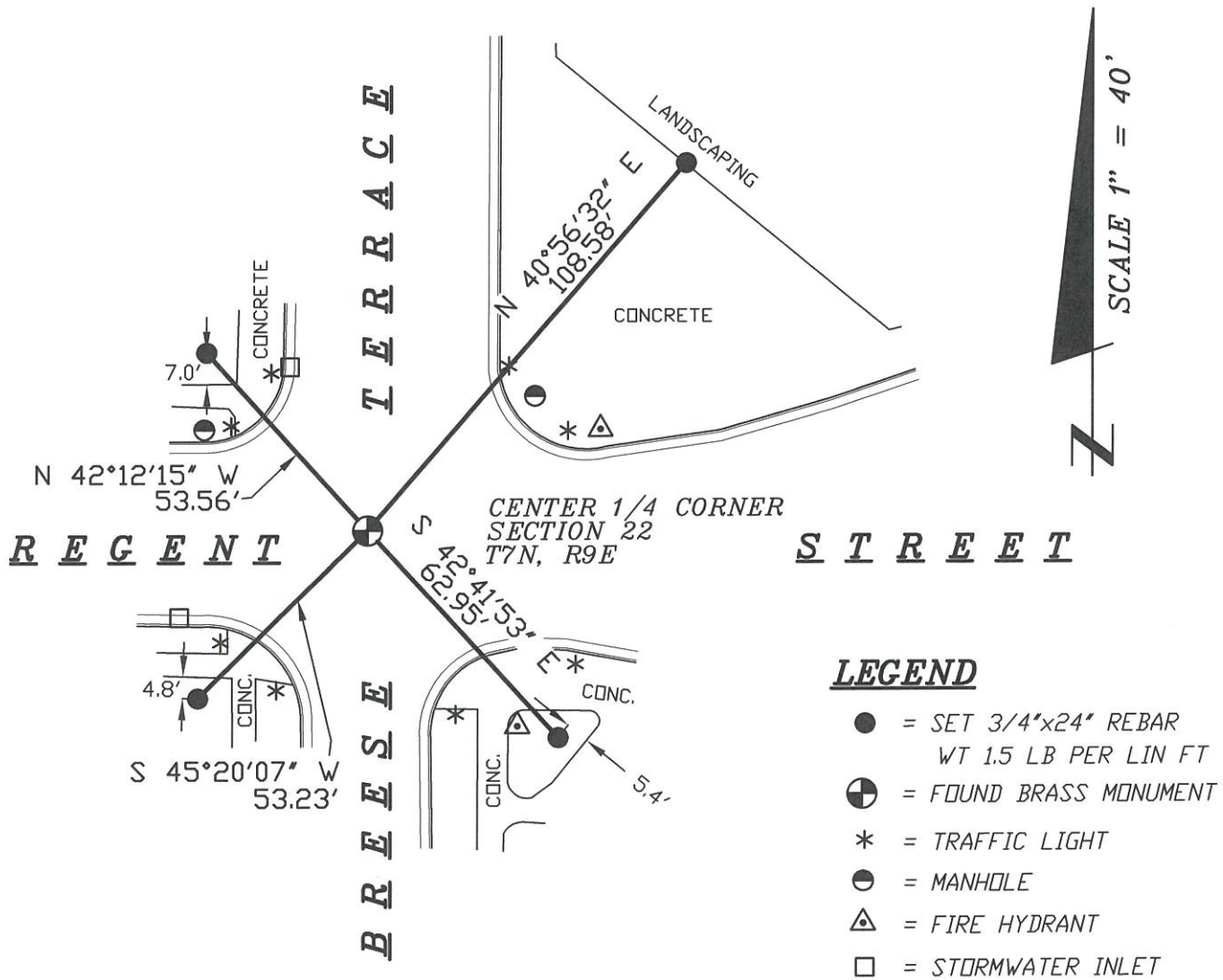

DESCRIPTION OF EVIDENCE:

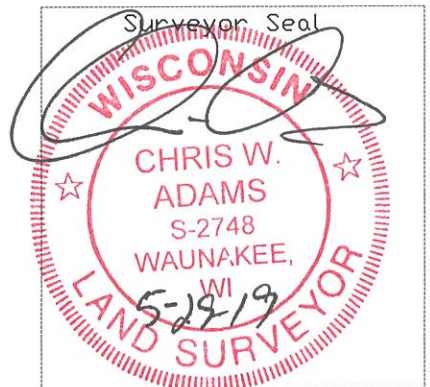
