### Please describe, in detail, the proposed project:

### THE NEED

In the fall of 2018, Community GroundWorks and Troy Farm lost access to rented space that was the longtime home of our Troy Farm Sprouts operation and a walk-in cooler at the Mendota Mental Health Institute. The walkin cooler housed all of the produce grown at Troy Farm, accounting for 90% of Troy Farm's total income. Troy Farm Sprouts accounts for 30% of Troy Farm's total income from sales.

In the spring of 2019, Community GroundWorks invested over \$63,000 of organizational reserves into Troy Farm. \$44,000+ was invested into farm upgrades at Troy Farm, including an 8'x12' mobile walk-in cooler. This cooler has proven to be undersized and underpowered for the scale of our operations. Additionally, \$18,000+ was invested in retrofitting a storage room into a sprout room at Badger Rock Neighborhood Center (BRNC). The BRNC sprout room is not climate controlled and is resulting in ongoing sprout production issues jeopardizing our wholesale accounts and the financial viability of the sprout operation.

Troy Farm is facing two separate situations that are jeopardizing our diversified vegetable farm operation and our sprout business. These two operations account for approximately 90% of our total farm revenue and make up the

entirety of the food grown that is delivered to income limited families and neighborhood centers in our community through our Food Access Initiative.

### THE ASK

Troy Farm is requesting up to, but not to exceed, \$35,000 of funding from the City of Madison's Healthy Retail Access Program (HRAP) to cover infrastructure costs associated with:

- A larger, on-site walk-in cooler (\$20,000)
- Ductwork to connect the Troy Sprout Room at the Badger Rock Neighborhood Center to the existing HVAC system (\$15,000)

### WALK-IN COOLER

All produce grown at Troy Farm (revenue: \$85,000 annual) as well as sprouts grown at Badger Rock Neighborhood Center (revenue: \$55,000 annual) require refrigeration. Since losing our walk-in cooler at the end of 2018, we have been using a walk-in cooler that is underpowered and undersized for our operations. This cooler has been housing all of Troy Farm's produce and sprouts up to this point in the 2019 season. This cooler is proving to be insufficient for the volume of produce and sprouts grown at Troy Farm. Produce that could be harvested for sale or donation is being left in the field. The existing walk-in cooler is sufficient and can continue to be used for warmer temperature crops. We are requesting funds to purchase a 10'x16' outdoor walk-in cooler with condenser unit for placement at Troy Farm – an estimated cost of \$16,254.

### SPROUT ROOM HVAC SYSTEM

In 2019 Troy Farm moved the Troy Farm Sprouts operation from the offices of the Mendota Mental Health Institute to the Badger Rock Neighborhood Center (BRNC). This move required an initial investment of over \$18,000 to retrofit a storage room in the BRNC into a licensed production facility. The Troy Farm sprout business generates over 30% (\$55,000) of Troy Farm's annual revenue. The sprout operation began production in its new facility in March of 2019. By May of 2019, the temperature and humidity levels in the new sprout room had become problematic for sprout production. The BRNC sprout room is not tied into the BRNC HVAC system, which means we do not have any means to regulate temperature and humidity levels. As a result, each week approximately ¼ of our total sprouts grown do not meet quality standards and cannot be sold. This has resulted in significant loss of sales jeopardizing wholesale accounts and also creating potential food safety concerns. We are requesting funds to connect the BRNC sprout room to the BRNC general facility's HVAC system - an estimated cost of up to \$20,000

### BACKGROUND + ADDITIONAL INFORMATION

### Community GroundWorks

Community GroundWorks (CGW) is a nonprofit organization working to create equitable + resilient food communities. We connect people to healthy food, land, and garden + farm-based education. One of the projects of CGW is Troy Gardens, a 26-acre property on Madison's northside that is part of the Madison Area Community Land Trust (MACLT). Troy Gardens includes Troy Community Garden, Troy Kids' Garden, and Troy Farm. CGW also oversees Gardens Network, (a partnership with City of Madison and UW-Extension with membership base of 69 community gardens across Dane County)

# Troy Farm

Troy Farm is Madison's first and largest certified organic, diversified vegetable farm. As a program of the nonprofit organization, Community GroundWorks, Troy Farm serves as both an education and production farm.

# Troy Farm's Education Programming

Community GroundWorks' Field School is an experiential learning community providing garden and farm-based education along an age, skills, and opportunity continuum. This model seeks to provide pathways for transforming individuals and communities through a continuum of garden and farm-based education, including paid internships.

Troy Farm's Urban Farmer Internship trains aspiring growers for careers that transform the local food system. We are currently developing pathways for youth from local neighborhood centers to engage with our garden and farm-based education from elementary age through high school and into paid internships and careers.

### Troy Farm's Production + Sales Channels

Over 90% of Troy Farm's total annual revenue comes from the sale of farm products through Troy Farm's various social enterprises. This revenue supports all of Troy Farm's operations and programs, including the Food Access Initiative and the Urban Farmer Internship program. Troy Farm's social enterprises include both direct to consumer sales (Troy Farm CSA, Troy Farm Stand, and Troy Farm Pizza) as well as wholesale accounts (Troy Farm Sprouts and Troy Farm Herbs).

### Troy Farm CSA + Farm Stand

The majority of the produce grown at Troy Farm is sold direct-to-consumer through our community supported agriculture (CSA) program and farm stand. In response to community feedback provided by northside residents (from a 2018 listening session at Mendota Elementary), in 2019 we made significant changes to our CSA program to make it more accessible to more people. We no longer offer a "traditional" CSA share option, but now offer one flexible "market-share" farm membership. The way it works is members sign-up in the Spring for their choice of credit (\$150, \$300, \$450, or \$600) at our farm stand and spend it down throughout the 20-week harvest season. Members choose not only what to buy, but when to shop, either at the Troy Farm Stand on Thursday evenings (4pm-7pm) at Troy Gardens or the Northside Farmers' Market on Sundays (8:30am-12:30pm). This model allows customers to get what they want, when they want it, providing the most flexible CSA model around. Read the "Food Access Initiative" section below for additional details on how this market model improves access to healthy, locally grown produce for income limited families in our community.

### **Troy Farm Sprouts**

Troy Farm's sprout operation accounts for approximately 30% of Troy Farm's total sales revenue and provides the farm's only source of year-round income. Troy Sprouts are grown indoors, as they require specific and consistent growing conditions of 70 degrees and 50% humidity. Troy Farm Sprouts are sold direct-to-consumer to our farm members and non-members at our Troy Farm Stand and also wholesale to local grocers and delis. Troy Farm Sprout income provides year-round funding for Troy Farm staff. Winter staffing is critical for advancing the goals of the Food Access Initiative, as this is when partnerships and outreach efforts are conducted. Since moving to the BRNC, Troy Farm Sprouts has also provided supplemental income to BRNC's Urban Farm Manager and Assistant Manager. In addition, improvements to the BRNC sprout room will provide opportunity to expand the sprout business, providing additional funding and staffing hours for existing BRNC staff and/or residents of the BRNC neighborhood.

# FOOD ACCESS INITIATIVE

### Overview

Troy Farm believes that all people should have access to affordable and healthy food. In 2018, we launched the Troy Farm Food Access Initiative to improve access to healthy, locally grown organic produce in our community. Our Food Access Initiative provides affordable, locally grown produce for income eligible families and neighborhood centers through subsidies of up to 50% for nonmembers and 75% for members.

Troy Farm and its two farm stand locations are located on Madison's northside in one of the identified focus areas of the 2018 City of Madison's Food Access Improvement Map.

### Troy Farm Stand

In 2019, Troy Farm is providing two opportunities per week for income eligible Troy Farm members and nonmembers to purchase subsidized locally grown, organic vegetables at the Troy Farm Stand. The Troy Farm Stand is open from June - October (20 weeks) on Thursdays (4pm-7pm) at Troy Gardens and on Sundays at the Northside Farmers Market (8:30am-12:30pm)

### Troy Farm Members

In partnership with FairShare CSA Coalition, Troy Farm is proud to be the only farm in the area offering up to 75% subsidies for farm membership to income eligible families and neighborhood centers. For instance, income eligible individuals and neighborhood centers can receive \$600 worth of produce for \$150! In addition, members can further reduce the financial burden of farm membership by using SNAP benefits and payment plans. Members shop at the farm stand choosing what they want, when they want it. In 2019, Troy Farm is providing 24 discounted shares for a total of \$10,950, which accounts for 16% of our total farm membership income. We are serving 15 individuals and 4 neighborhood centers, including (Bayview, Packers, Vera Court, and Warner Park through Coach Wood's Prevention and Intervention Program operating out of Warner Park Community Center). Our goal is to continue to increase access to income eligible individuals through additional partnerships with local neighborhood centers.

### Troy Farm Non-members (open to public)

In partnership with the Community Action Coalition, income eligible non-members with SNAP benefits can receive up to 50% off the cost of produce through the Double Dollars Program.

### Farm to Neighborhood Center Initiative

We have partnered with local neighborhood centers with which we already have relationships to reach a more diverse audience, historically overlooked due to income limitations. We not only are providing affordable, healthy food to families, but also to neighborhood centers for programming. We call this our "farm-to-neighborhood center initiative" and believe this model is replicable and scalable. Neighborhood centers can access the same (up to 75% off) subsidies as the families that frequent the neighborhood centers, allowing centers to use fresh, locally grown produce in their meals and programming. In 2019, Troy Farm is working with four neighborhood centers/programs and is looking to expand in 2020.

### Donations

In 2019, Troy Farm has donated 730 lb (to date) of produce to local food pantries and programs. Our partners/recipients include: Kennedy Heights Food Pantry, The River Food Pantry, Healthy Food for All, Lakeview Lutheran Food Pantry, and Coach Wood's Prevention and Intervention Program. In addition to weekly donations, we are piloting a program this year in which all Troy Farm members can donate unused credit to our community partners, reducing waste and increasing the overall donations to our partners.

### Outreach

Troy Farm's Food Access Initiative provides affordable, locally grown produce to income eligible families as well as neighborhood centers and programs that serve income eligible families. This year we provide more subsidized memberships than any previous year, and we have partnered with four neighborhood centers. We want to expand this effort even further. This coming winter we will embark on an outreach effort to identify and recruit additional income eligible families and neighborhood centers with which to serve and partner. Our goal is to double our Food Access Initiative members and shares each year until we reach a 50% of total farm membership.

**Center for Resilient Cities:** Since March of 2019, Badger Rock Neighborhood Center has housed the Troy Farm sprout operation.

**FairShare CSA Coalition:** Partner Shares Program helps provide up to 75% off subsidies for Troy Farm's Food Access Initiative.

**Community Action Coalition:** Double Dollars Program provides 50% discount to Troy Farm Stand shoppers with SNAP benefits.

**Neighborhood Centers:** Receive subsidized Troy Farm membership for various programs

- Vera Court Neighborhood Center: Troy Farm produce is used in summer school camp snacks prepared by the Kids Café, and kids are sent home with left over veggies
- Packers' Learning Center: Will use produce in the fall for after-school snack time
- Bayview Foundation: Youth participate in a cooking club to learn about nutritious food, produce is also used as snacks in other programs, and families are given veggies directly through the center's food shelf
- Warner Park/Coach Wood's Program for Intervention and Prevention: Coach Haywood Simmons' summer program seeks to provide Northside teens with healthy summer activities. Participants are given the opportunity to help in the fields at Troy Farm, work their own garden in Troy Community Garden, and prepare healthy snacks using Troy Farm produce with Coach Wood at Warner Park Rec Center.

RE: Sprout Room HVAC Needs

Hello Garrett,

I wanted to give you a brief breakdown on why we need to proceed with the needed HVAC upgrades for the sprout room that you are utilizing in the Badger Rock Center at 501 E Badger Rd. The room that you are utilizing was originally designed as a storage room with no air conditioning at all. The heat for this room runs off of the inground heating loop which was sized to merely maintain a heat level around 65 degrees. During the cooling season this room is not being controlled. With no cooling, the room temperature can rise much higher than wanted for growing purposes. There is also a concern of humidity damaging the other equipment in the room as the design of the room was not intending to have so much water in the space.

In order for you to properly condition the space, supplemental cooling would need to be added. There are many different ways that this can be accomplished but it needs to be done in line with the building's energy standards and systems. We have designed to install an electric heat pump that works with the existing geo thermal and Dedicated Outside Air System (DOAS). Once the equipment is installed, we will adjust the Building Automated Systems (BAS) to recognize and control the temperature in the room.

As we understand that costs can always be a concern, this is the best route to take in order to properly maintain the room while trying to give you as close to the needed temperatures as possible.

Members of the Madison Food Policy Council:

I am writing to provide a brief history of FairShare CSA Coalition's partnership with Troy Farm through our Partner Shares Program, and to express our enthusiastic support of Troy Farm's initiatives to expand fresh food access for north side residents.

The Partner Shares Program began in 1995 with the goal to improve financial and geographic access to fresh, local vegetables while also ensuring that area farmers receive market price for their products. The Partner Shares Program provides financial assistance (50% off, up to \$300) to eligible households and organizations that purchase a CSA share through a FairShare-endorsed farm.

Troy Farm has been a unique and critical partner in our efforts to support families on the north side of Madison, a focus area for the Partner Shares Program as it has been identified as an area with both limited income and limited access to fresh food. Troy Farm has made fresh vegetables even more accessible to their neighbors by raising funds to offer an <u>additional</u> 25% discount to eligible families through the Partner Shares Program. They have also formed and maintained several robust partnerships with community centers and neighborhood programs on the north side, resulting in increased fresh vegetable consumption among residents and the promotion of healthy food options.

Considering its relatively small production size, Troy Farm has a significant percentage of Partner Shares members. We attribute this outcome to Troy Farm's thoughtful dedication to serving their closest neighbors and their hard work in realizing this goal through outreach and promotional efforts, as well as in their purposeful transition to the market share model. Market shares allow customers to select their own produce, similar to visiting a regular farmer's market stand, which may feel more accessible to those who are unfamiliar with the traditional CSA model.

We look forward to continuing our relationship with Troy Farm and supporting the potential growth of the Partner Shares Program on the north side of Madison.

Greetings Healthy Retail Access Committee!

Joe Mingle here from Healthy Food For All and the Darbo Pantry Project. I'm writing to give my strongest possible endorsement for the Troy Farm cooler expansion proposal.

Community Groundworks and Troy Farm have been on the cutting edge of building the local food movement for many, many years. One of our key community partners, Troy Farm donates large volumes of surplus produce that we are then able to redistribute to area households who need increased access to fresh, local food.

For example, DPP delivers free bags of mixed local produce to 40 households in the Darbo-Worthington neighbor each week. Donations from Troy Farm often give us the extra bulk produce to ensure every household gets a full bag. Additional cold storage space would allow Troy Farm to glean even more surplus produce from their fields, share more with the community and help us deliver to even more households.

In addition to directly supporting Troy's ability to donate surplus produce, additional on site cold storage space would allow Troy to provide bulk produce for use by local value added product businesses. Currently, the local food system infrastructure lacks adequate on-farm cold storage to allow most farmers to contract with other producers for bulk produce.

For example, Badger Kraut & Pickle, a new local food start-up, needs large volumes of cabbage to make its product. BK&P would be able to contract with Troy to grow all or most of the needed cabbage if they had the capacity to harvest and store it until processing at FEED Kitchens. FEED Kitchens' cold storage is very limited which can constrain the growth of small local food businesses as they seek to scale up. Having an urban farm nearby with the capacity to grow and store bulk produce for medium scale enterprises would be a significant step forward in the development of the local food system infrastructure.

Providing support tp expand Troy Farm's cold storage capacity would be an excellent community investment. This additional, critical piece of local infrastructure will not only have a direct, immediate impact on neighbors lacking access to fresh local produce but will also help support local food businesses as they start up and expand. Both HFFA and DPP hope the Committee will support this important effort!
